Jeffrey - we tried you on a few different lines. Matt's direct again [REDACTED] if you want to just talk with him.

On the FX front - your USDRUB binary has 7 trading days of time value left in it. Know you're well aware, but the \$257k premium looking to expire worthless. You're 102.5 \$/Y call is leaking time value - matures 5/15, so want to keep that front of mind as the yen is favorably weakening vs. the dollar here. We have you plugged into US FX trader (212-454-8865, Caleb David) and, in addition to Nav and Vinit in London, finalizing the trader connection in Europe for you - as of now, you can speak direct with Roger Posch, [REDACTED], but I need to be on the line for licensing purposes.
