Receipt of Information from ██████████ Facility Manager, Federal Bureau of Prisons

On October 1, 2021, through March 10, 2022, Assistant Special Agent in Charge ██████████, U.S. Department of Justice Office of the Inspector General (OIG), received the attached emails from Facility Manager ██████████ Federal Bureau of Prisons (BOP), Metropolitan Correctional Center (MCC), New York, New York. ██████████ was interviewed by the OIG on August 4, 2021, in reference to an official OIG investigation into the events surrounding the death of BOP inmate Jeffrey Epstein, Register Number 76318-054, who was previously housed within the MCC New York. ██████████ was the Facility Manager at the MCC New York when Epstein was housed within the MCC New York. The emails received from ██████████ were in reference to the topics discussed during ██████████ interview, and are in specific reference to the MCC New York camera system. The interview of ██████████ is documented within a separate Memorandum of Investigation.
