URGENT

Dear The Hon Ronald Sackville AO QC Chair of the Royal Commission,

I have attached to this email my: "*Resume*" as supporting evidence to this email.

I spent over a Decade; completing both: **1) Law & 2) Business Academic** Qualifications. Firstly, my "**Time**" has been significantly wasted and secondly; my parents and I spent close to a Million Dollars completing my rigorous academic programs at Bond University Limited (Their Web-site is available at: <https://bond.edu.au/>) and other leading Education Providers.
