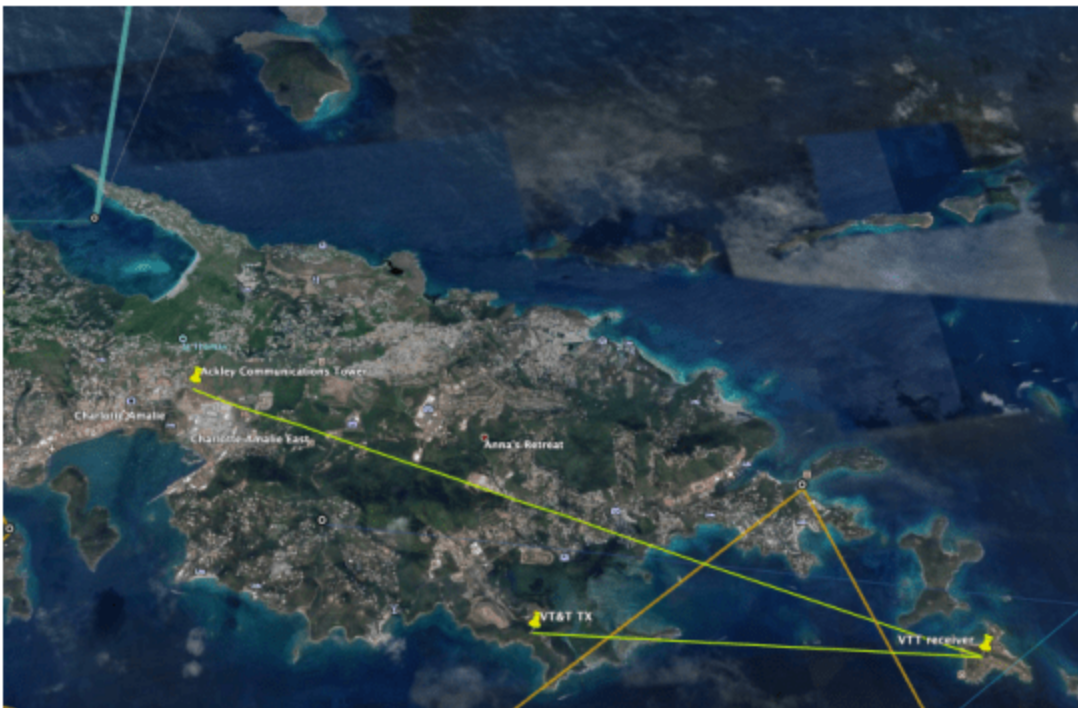

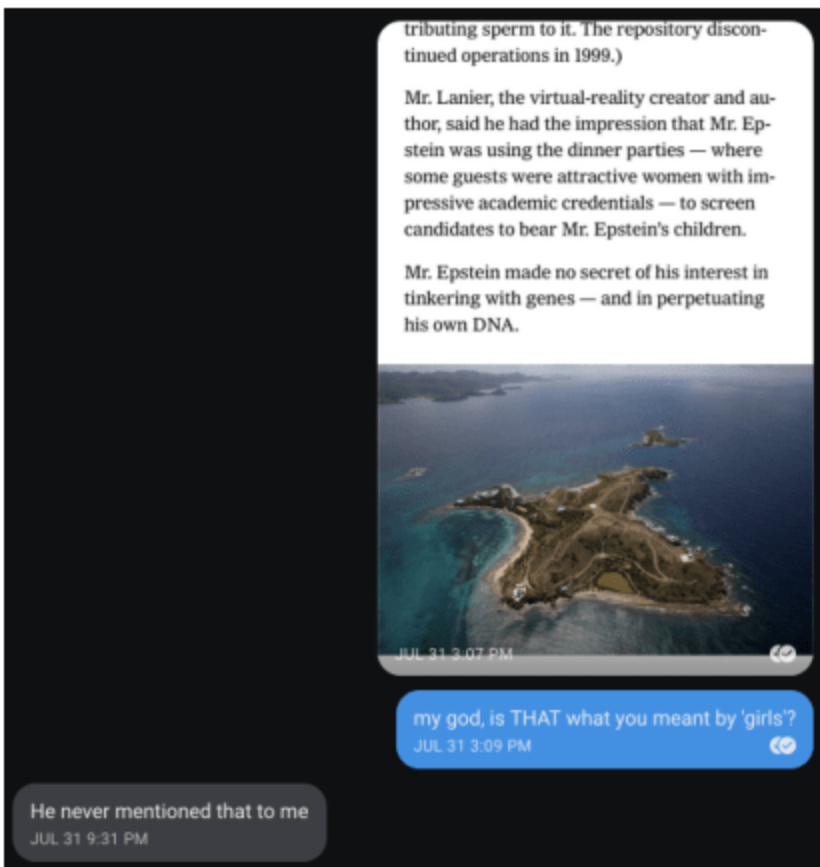


Compare Epstein's proximity to both Columbus II-b and the USVI circuit below.



Unfortunately, I also have reason to believe - [given statements made by Ethan Zuckerman of the MIT Media Lab](#) - that the Little Bits engineering kits that were largely targeted at pre-teen girls - were funded at least in part by Epstein in connection with [Neoteny Labs](#).
