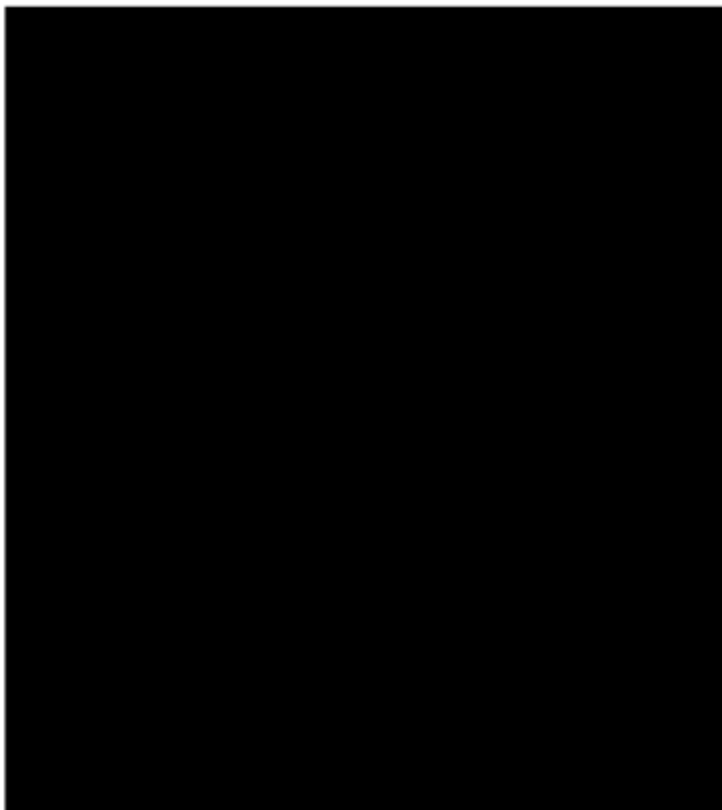

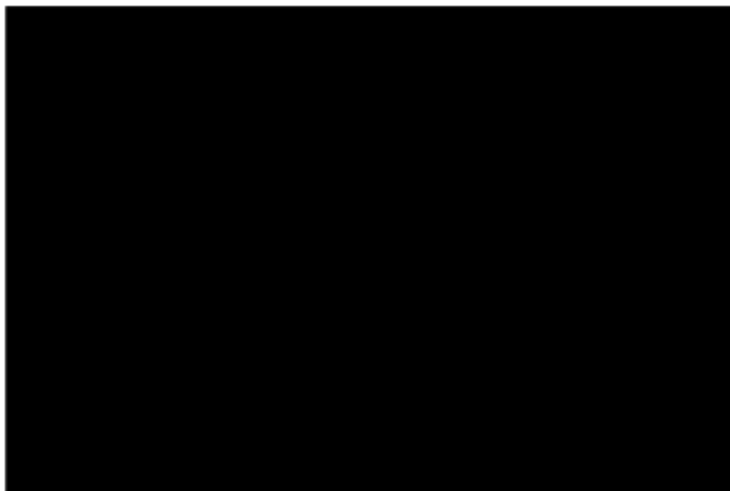
Hey [REDACTED],

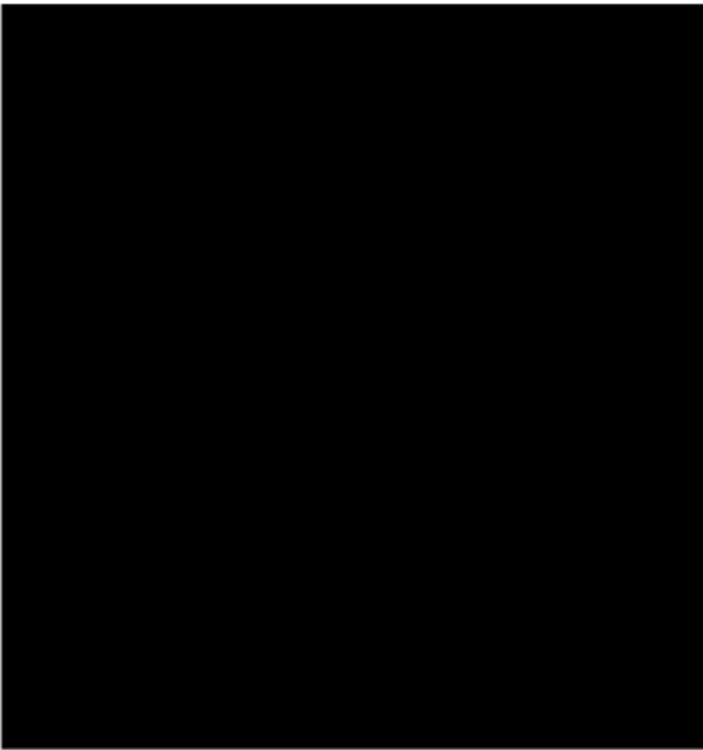
