Prosecutors Say Ghislaine Maxwell “At Serious Risk Of Being Beaten Or Killed By Fellow Prisoners.” The Sun (UK) (8/14, 712K) reported that “Ghislaine Maxwell is being held in solitary confinement in a notorious Brooklyn jail for her own safety, prosecutors have said.” Prosecutors say Maxwell remains in isolation for reasons of “safety, security, and the orderly functioning of the facility.” Maxwell’s lawyers have “objected to her being subjected to round-the-clock surveillance and numerous body scans at the Metropolitan Detention Center.”
