A similar \$50-million suit was filed in March 2008, by a different woman, who was represented by the same lawyer.^[129] These and several similar lawsuits were dismissed.^[130]

All other lawsuits have been settled by Epstein out of court.^[131] Epstein made many out-of-court settlements with alleged victims.^[130]

Victims' rights: *Jane Does v. United States* (2014)

*** SEXUAL ABUSE RING ***
PROMINENT POSITIONS

A December 30, 2014, federal civil suit was filed in Florida by Jane Doe 1 (██████████) and Jane Doe 2 against the United States for violations of the Crime Victims' Rights Act by the U.S. Department of Justice's NPA with Epstein and his limited 2008 state plea. There was a later unsuccessful effort to add ██████████ (Jane Doe 3) and another woman (Jane Doe 4) as plaintiffs to that case.^[132] The addition accused Alan Dershowitz of sexually abusing a minor, Jane Doe 3, provided by Epstein.^[133] The allegations against Dershowitz were stricken by the judge and eliminated from the case because he said they were outside the intent of the suit to re-open the plea agreement.^{[134][135]} A document filed in court alleges that Epstein ran a "sexual abuse ring" and lent underage girls to "prominent American politicians, powerful business executives, foreign presidents, a well-known prime minister, and other world leaders".^[136]

This long-running lawsuit is pending in federal court, aimed at vacating the federal plea agreement on the grounds that it violated victims' rights.^[137] On April 7, 2015, Judge Kenneth Marra ruled that the allegations made by alleged victim ██████████ against Prince Andrew had no bearing on the lawsuit by alleged victims seeking to reopen Epstein's non-prosecution plea agreement with the federal government; the judge ordered that allegation to be struck from the record.^[134] Judge Marra made no ruling as to whether claims by ██████████ are true or false. Though he did not allow Jane Does 3 and 4 to join the suit, Marra specifically said that ██████████ may later give evidence when the case comes to court.^[138]

On February 21, 2019, in the case of *Two Jane Does v. United States*, Senior Judge of the U.S. District Court for the Southern District of Florida Kenneth Marra said federal prosecutors violated the law by failing to notify victims before they allowed him to plead guilty to only the two Florida offenses. The judge left open what the possible remedy could be.^[139]

██████████ v. Epstein (2015)

In a December 2014 Florida court filing by Bradley Edwards and Paul G. Cassell meant for inclusion in the Crime Victims Rights Act lawsuit,^[140] ██████████ (then known as ██████████), alleged in a sworn affidavit that at age 17, she had been sexually trafficked by Epstein and Ghislaine Maxwell for their own use and for use by several others, including Prince Andrew^[141] and retired Harvard Law professor Alan Dershowitz.^{[8][142]} ██████████ also claimed that Epstein, Maxwell and others had physically and sexually abused her.^[143] She alleged that the FBI may have been involved in a cover-up.^[144] She said she had served as Epstein's sex slave from 1999 to 2002, and had recruited other underage girls.^[145] Prince Andrew, Epstein, and Dershowitz all denied having had sex with ██████████. Dershowitz took legal action over the allegations.^{[146][147][148]} ██████████ filed a defamation suit against Dershowitz,

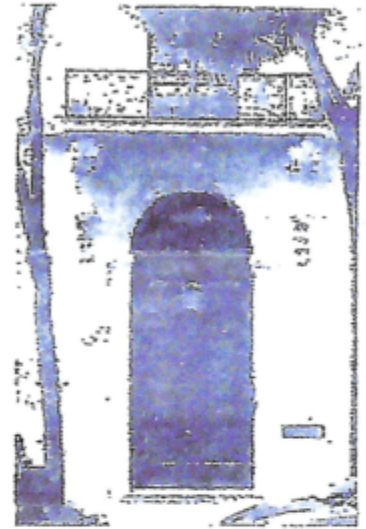

Bloom asserted that the woman had received threats. The suit was dropped on November 4, 2016. Trump attorney Alan Garten denied the allegations, while Epstein declined to comment. [156][157][158][159][160]

v. Epstein and Maxwell (2017)

In 2017, [redacted] filed a suit against Epstein and Maxwell, alleging that Maxwell had hired her to give massages to Epstein and later threatened to physically harm her or destroy her career prospects if she did not comply with their sexual demands at his mansion in New York City and on his private Caribbean island, Little Saint James. The suit was settled in 2018 under undisclosed terms. [161][162]



Epstein was accused of sex trafficking of minors at his mansion at 9 East 71st Street.

Bradley Edwards' defamation v. Epstein (2018)

A state civil lawsuit in Florida filed by attorney Bradley Edwards against Epstein was scheduled for trial in December 2018. The trial was expected to provide victims with their first opportunity to make their accusations in public. However, the case was settled on the first day of the trial, with Epstein publicly apologizing to Edwards; other terms of the settlement were confidential. [137][163]

v. Epstein and Maxwell (2019)

On April 16, 2019, [redacted] went public and filed a sworn affidavit in federal court in New York, alleging that she and her 15-year-old sister, [redacted], had been sexually assaulted by Epstein and Maxwell in separate locations in 1996. [redacted] met Epstein and Maxwell at her graduate art gallery reception at the New York Academy of Art in 1995. The following year, in the summer of 1996, they hired her to work on an art project in Leslie Wexner's Ohio mansion, where she was then sexually assaulted. [164] [redacted] reported the incident to the New York City Police Department and the FBI. [165]

[redacted] affidavit also stated that during the same summer, Epstein flew her then-15-year-old sister to his New Mexico property where he and Maxwell sexually abused her on a massage table. [166]

v. Epstein and Maxwell (2019)

On July 22, 2019, while in jail awaiting trial, Epstein was served with a petition regarding a pending state civil lawsuit filed by [redacted]. [167] She stated that an associate for Epstein had recruited her outside [redacted] at age 14 and she was gradually groomed for over a year before Epstein raped her in his New York City mansion when she was 15. [168] [redacted] filed her suit on August 14, 2019, when New York State law was updated to allow one year for adult survivors of child sexual abuse to sue for previous offenses, regardless of how long ago the abuse took place. [169] In October 2019, [redacted] amended her complaint to include over 20 corporate entities associated with Epstein and named the additional individuals Lesley Groff and [redacted] as enablers. [170]

Katlyn Doe, et al. v. Epstein's estate (2019)

Liquid Funding was initially 40 percent owned by Bear Stearns. Through the help of the credit rating agencies – Standard & Poor's, Fitch Ratings and Moody's Investors Service – the new bundled securities were able to be created for companies so that they got a gold-plated AAA rating. The implosion of such complex securities, because of their inaccurate ratings, led to the collapse of Bear Stearns in March 2008 and set in motion the financial crisis of 2007–2008 and the subsequent Great Recession. If Liquid Funding were left holding large amounts of such securities as collateral, it could have lost large amounts of money.^{[65][67]}

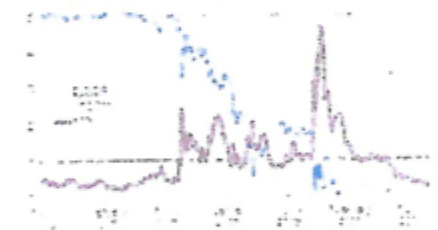
Investments

Hedge funds

Between 2002 and 2005, Epstein invested \$80 million in the D.B. Zwirn Special Opportunities Fund, a hedge fund that invested in illiquid debt securities.^{[68][69]} In November 2006, Epstein attempted to redeem his investment after he was informed of accounting irregularities in the fund.^[70] By this time, his investment had grown to \$140 million. The D.B. Zwirn fund refused to redeem the investment. Hedge funds that invest in illiquid securities typically have years-long "lockups" on their capital for all investors and require redemption requests to be made in writing 60 to 90 days in advance.^[68] The fund was closed in 2008, and its remaining assets of approximately \$2 billion, including Epstein's investment, were transferred to Fortress Investment Group when that firm bought the assets in 2009.^{[68][69]} Epstein later went to arbitration with Fortress over his redemption attempt. The outcome of that arbitration is not publicly known.^[68]

 invested \$57 million in the Bear Stearns High-Grade Structured Credit Strategies Enhanced Leverage hedge fund.^{[68][72]} This fund was highly leveraged in mortgage-backed collateralized debt obligations (CDOs).^[72]

On April 18, 2007, an investor in the fund, who had \$57 million invested, discussed redeeming his investment.^[73] At this time, the fund had a leverage ratio of 17:1, which meant for every dollar invested there were seventeen dollars of borrowed funds; therefore, the redemption of this investment would have been equivalent to removing \$1 billion from the thinly traded CDO market.^[74] The selling of CDO assets to meet the redemptions that month began a repricing process and general freeze in the CDO market. The repricing of the CDO assets caused the collapse of the fund three months later in July, and the eventual collapse of Bear Stearns in March 2008. It is likely Epstein lost most of this investment, but it is not known how much was his.^{[73][72]}



The government began negotiation with Epstein for a plea agreement in mid-2007, as the hedge fund began to collapse.

By the time that the Bear Stearns fund began to fail in May 2007, Epstein had begun to negotiate a plea deal with the U.S. Attorney's Office concerning imminent charges for sex with minors.^{[68][74]} In August 2007, a month after the fund collapsed, the U.S. attorney in Miami, Alexander Acosta, entered into direct discussions about the plea agreement.^[71] Acosta brokered a lenient deal, according to him, because he had been ordered by higher government officials, who told him that Epstein was an individual of importance to the government.^{[52][53]} As part of the negotiations, according to the *Miami Herald*, Epstein provided "unspecified information" to the Florida federal prosecutors for a more lenient sentence and was supposedly an unnamed key witness for the New York federal prosecutors in their unsuccessful June 2008 criminal case against the two managers

John Winston Howard OM AC (born 26 July 1939) is an Australian former politician who served as the 25th prime minister of Australia from 1996 to 2007, holding office as leader of the Liberal Party of Australia. His eleven-year tenure as prime minister is the second-longest in history, behind only Sir Robert Menzies, who served for eighteen non-consecutive years. He has also been the oldest living former Australian prime minister since the death of Bob Hawke in 2019.

Howard was born in Sydney and studied law at the University of Sydney. He was a commercial lawyer before entering parliament. A former federal president of the Young Liberals, he first stood for office at the 1968 New South Wales state election, but lost narrowly. At the 1974 federal election, Howard was elected as a member of parliament (MP) for the division of Bennelong. He was promoted to cabinet in 1977, and later in the year replaced Phillip Lynch as treasurer of Australia, remaining in that position until the defeat of Malcolm Fraser's government at the 1983 election.

In 1985, Howard was elected leader of the Liberal Party for the first time, thus replacing Andrew Peacock as Leader of the Opposition. He led the Liberal-National coalition to the 1987 federal election, but lost to Bob Hawke's Labor government, and was removed from the leadership in 1989. Remaining a key figure in the party, Howard was re-elected leader in 1995 (replacing Alexander Downer), and subsequently led the Coalition to a landslide victory at the 1996 federal election.

After defeating Paul Keating's Labor government in 1996, the Howard Government was re-elected at the 1998, 2001 and 2004 elections. Howard's actions as prime minister included implementing new gun laws in response to the Port Arthur massacre; the introduction of a nationwide value-added tax, immigration reform, and a controversial set of industrial relations reforms. Under his governance, Australia also contributed troops to the War in Afghanistan and the Iraq War, and led the International Force for East Timor. The Howard government was defeated at the 2007 federal election, with the Labor Party's Kevin Rudd succeeding him as prime minister. Howard also lost his own seat of Bennelong at the election to Maxine McKew, becoming only the second prime minister to do so, after Stanley Bruce in 1929. Following this loss, Howard retired from politics.

John Hill (Australian politician)

John David Hill (born 3 December 1949), Australian politician, represented the electoral district of Kaurna in the South Australian House of Assembly for the Labor Party from 1997 to 2014.

Born in Sydney, Hill attended the University of Sydney and graduated with a Bachelor of Arts. He moved to South Australia in 1974 and became a teacher. He also studied at the University of Adelaide and received his law degree.

Following a brief stint as a ministerial adviser during the Bannon Government, Hill became a party official, becoming State Secretary in 1994. He was elected to Parliament as member for Kaurna at the 1997 state election.

After Labor won the 2002 election, Hill became a minister in the Rann Government. Initially given the portfolios of Minister for Environment and Conservation, Minister for the River Murray, Minister for the Southern Suburbs, Minister Assisting the Premier in the Arts and Minister for Gambling, Hill gained his current portfolios after a number of cabinet reshuffles.

The 2006 election saw Hill gain a swing of 11.0% to a total margin of 22.0%.

Hill did not re-contest his seat at the 2014 election.^[1]

Hill is a member of the Ministers' Club at EPODE International Network – the world's largest obesity-prevention network.^{[2][3]}

John Hill's political memoir, *On Being a Minister - Behind the Mask*, was published in February 2016.^[4]

Marshall entered South Australian Parliament at the 2010 state election, winning the seat of Norwood as a candidate for the South Australian Division of the Liberal Party of Australia.^[5] In the December 2011 reshuffle of the opposition's front bench, Marshall was moved from the back bench to take on the shadow portfolios of industry and trade, defence industries, small business, science and information economy, environment and conservation, sustainability and climate change.^[6]

Marshall said in August 2012 that he would be willing to sign a pledge that he would not challenge Isobel Redmond for the Liberal Party leadership or Mitch Williams for the deputy leadership.^[7] On 19 October 2012, Martin Hamilton-Smith and Marshall declared a leadership spill against Redmond and Williams.^{[8][9]} In a partyroom ballot occurred on 23 October 2012, Redmond retained the leadership by one vote; however, Marshall was elected to the deputy leadership.^{[5][10][11]} Marshall was denied his preferred treasury portfolio by Redmond,^{[12][13]} but instead was given the health and economic development portfolios, while retaining his roles in industry and trade, defence, small business and science.^[14]

Leader of the Opposition

On 31 January 2013 after Redmond resigned as Leader of the Opposition and Leader of the SA Liberals, it was speculated that Marshall would succeed her. At the ballot on 4 February 2013, Marshall was elected unopposed.^[15]

2014 state election

The 2014 state election was held on 15 March. Marshall faced Labor leader Jay Weatherill, who had replaced Mike Rann in 2011. Leading up to the election, the SA Liberals had led Labor in every recorded Newspoll since 2009. The election resulted in a hung parliament with 23 seats for Labor and 22 for the Liberals with the Liberals winning a majority of the two party preferred vote. The balance of power then rested with the two crossbench independents, Bob Such and Geoff Brock. Such did not indicate who he would support in a minority government before he went on medical leave for a brain tumour, diagnosed one week after the election. With 24 seats required to govern, Brock provided support to the incumbent Labor government, allowing Weatherill to continue in office as head of a minority government, with Brock given a ministry portfolio.^[16]

*GEOFF BROCK - 2009 MEDICAL BUSINESS PLAN - DENIED FUNDING.
The day before the election, Marshall made a political gaffe, saying by mistake "If people in South Australia want change, they want a better future, they want to grow our economy then they need to vote Labor tomorrow".^{[17][18][19]} Marshall contested Dunstan, essentially a renamed version of Norwood, and suffered a 1.7% two-party (2PP) swing. A swing against the Liberals occurred in seven of the nine Liberal-retained metropolitan seats.^a

After the election, Marshall continued to lead the Liberals in opposition.^[20] Former Liberal leader Martin Hamilton-Smith became an independent two months after the election and indicated his support for the government.^[21] Following the death of Such and the subsequent 2014 Fisher by-election which Labor won by five votes from a 7.3% 2PP swing away from the Liberals, Labor went from minority to majority government. Brock and Hamilton-Smith maintained their confidence and supply support for the government which provided a 26 to 21 parliamentary majority.^[22]

* 2018 state election

The 2018 state election was held on 17 March. The July to September 2014 Newspoll had seen Labor begin to lead the Liberals on the two-party-preferred vote for the first time since 2009.^[23] The October to December 2015 Newspoll saw Marshall's leadership approval rating drop 11 points to 30%, the equal lowest Newspoll approval rating in history for a South Australian Opposition Leader since Dale Baker in 1990.^{[24][25][26]} At the election, Marshall again faced Weatherill and Labor which were seeking a record fifth term in office and the "wild card" centrist party, SA-Best, led by former Senator Nick Xenophon, who was seeking the balance of power in the Assembly. The 2016 electoral redistribution had given the Liberals an advantage of 27 seats to Labor's 20 seats heading into the election.

* JOHN OLSEN - KADINA - COMMENCEMENT OF TARGETING *

Four hours after the close of polls on election day, at approximately 10pm ACDST, Weatherill telephoned Steven Marshall and conceded defeat. Marshall was introduced to the election day function by former Liberal Premier John Olsen and claimed victory. The SA Liberals had won the election with 25 seats to Labor's 19, a bare majority of two – the first time the Liberals had won a state election since Olsen's victory in 1997.^{[27][28][29][30]} Despite the outcome, there was actually a state-wide two-party-preferred swing away from the Liberals toward Labor.^[31]

* CONNECTED TO STEVEN MARSHALL - CONSPIRING AGAINST TARGETED VICTIM IN 2020 WITH VICKIE CHAPMAN, SA ATTORNEY GENERAL. Premier of South Australia

Two days after the election, with the result beyond doubt even though counting was still under way, Marshall had himself, deputy leader Vickie Chapman, and Father of the South Australian Parliament Rob Lucas sworn in as an interim three-person government by the Governor of South Australia, Hieu Van Le. Marshall became Premier, Chapman Deputy Premier and Attorney-General, and Lucas Treasurer. Lucas had previously served as Treasurer in the last Liberal government.^[32] The full ministry was sworn in on 22 March.^[33] In addition to serving as Premier, Marshall retained responsibility for portfolio areas of The Arts, Aboriginal Affairs and Reconciliation, Defence and Space Industries, Veterans' Affairs and Multicultural Affairs, although these were no longer named as ministries.^[34]

Vickie Ann Chapman (born 21 June 1957) is an Australian politician, representing the South Australian House of Assembly seat of Bragg for the South Australian Division of the Liberal Party of Australia since the 2002 election. Chapman served as the Deputy Premier of South Australia and Attorney-General between 19 March 2018 and 22 November 2021 in the Marshall government.^[1] She was the first woman to hold either post.

Chapman has previously served as deputy leader of the Liberal Party from 2006 to 2009, and became deputy leader again in 2013. Early life

Chapman was born on Kangaroo Island. One of seven children, Chapman attended the Kangaroo Island Parndana Area School, and following the death of her mother at age 12, she later attended Pembroke School in Adelaide. She studied a law degree at the University of Adelaide and graduated in 1979 as a barrister.

Chapman's father, Ted, was a member of the Liberal and Country League and then the South Australian Division of the Liberal Party of Australia in the South Australian House of Assembly. A Liberal moderate, Ted was a member of the Steele Hall-led Liberal Movement faction in the 1970s and

week before the 2010 election for not being willing to publicly refuse challenging Redmond for the leadership and faced accusations, particularly by Hamilton-Smith, of derailing the Liberal campaign, with "Chapman Could Challenge" posters hung beneath many of the Liberal "Redmond is Ready" posters.^[6]

Chapman was reappointed deputy opposition leader on 4 February 2013, and chose to announce she would rule out challenging new leader Steven Marshall.^[7]

Upon the fourth consecutive Liberal loss at the 2014 election, Chapman suffered a 1.5-point two-party swing but still retained Bragg with a comfortably safe 68.7 percent two-party vote.

Chapman lost a vote of non-confidence as Deputy Premier in the South Australian Parliament on 18 November 2021 after a parliamentary inquiry found her conflict of interest as Minister for Planning and Local Government and recommended for her to be found guilty of contempt of parliament for misleading the house.^[8] She resigned as Deputy Premier on 22 November 2021.^[9]

Personal life

One of her children is Channel 7 reporter Alex Hart.^[10]

* In 2015 Ramsey commended the Government of South Australia for initiating the Nuclear Fuel Cycle Royal Commission. Commencing in March 2015, the Commission was tasked to investigate the opportunities and risk of further nuclear industrial development for South Australia, which includes mining, processing, power generation and waste management. He said of the decision:

"I congratulate the Premier on this move; we simply cannot make sensible informed decisions about this industry if we don't talk about it."^[3]

* Ramsey supports the potential storage of low and intermediate level nuclear waste in his electorate of Grey. He intended to nominate his own property as a potential candidate site, but was advised not to by Minister Ian Macfarlane due to a perceived conflict of interest.^[4] He told the media:

"I would be more than happy, for instance, to host it on my farm. But I wouldn't nominate my farm without actually speaking to my neighbours and having a community consultation."^[5]

Up to four sites within his electorate have been nominated.^[4]

Following providing my bank account details I informed Officer Leong that this was a case of Identity Theft. Officer Leong agreed with me on the case of Identity Theft and informed me that the case would be referred to Federal Agencies - Federal Police.- Legal Investigation.

Officer Leong then informed me that my bank accounts and Tax file number would not be subjected to a suspension and the case would be referred to the Federal agencies for a thorough investigation and I was not instigated in the illegal activity that had occurred because of the Identity Theft - Legal Investigation.

I was informed by Officer Leong that the details would be sent to me via email services.

I have not received an email from Officer Leong concerning this matter and contact.

Currently my email service registered under a business registration with GoDaddy is under investigation for email hacking and Malicious Activity that has been reported by myself and occurring in 2020 - 2021.

As confirmed by Telstra Head office, concerning continuous Fraudulent Activity occurring in all accounts over a 10 year period, the source of the continuous Fraudulent Activity in every account, server has been a result of Remote Access to servers, accounts and Computer Hardware resulting in blocked access, blocked contact, altered details and Fraudulent Activity and has been conducted by Government and Police Sources Government and Police Targeting over a 27 year period resulting in Specific Targeting of an Individual by the use of Technology - Illegal Government and Police Surveillance, and shared surveillance from location to location, and following relocation

Jane Doe v. Maxwell and Epstein's estate (2020)

In January 2020, a lawsuit was filed against Maxwell and Epstein alleging that they recruited a 13-year-old music student at the Interlochen Center for the Arts in 1994 and subjected her to sexual abuse^[181] The suit states that Jane Doe was repeatedly sexually assaulted by Epstein over a four-year period and that Maxwell played a key role in both her recruitment and by participating in the assaults.^[181]

Jane Does v. Epstein estate (2020)

In August 2020 9 Jane Does filed suit accusing Epstein of sexual abuse. The alleged victims in the lawsuit include a 11 and 13 year old and a victim who alleged abuse in 1975.^[182]

Jane Doe v. Epstein estate (2020)

In August 2020 Epstein was sued by a Jane Doe accusing him of sexually abusing her for one and a half years, beginning when she was an 18-year-old aspiring singer and model in New York.^[183]

A civil suit was filed against Epstein's estate in March 2021 by a Broward County woman who accused Epstein and Maxwell of trafficking her after repeatedly raping her in Florida in 2008.^[184]

nice to me and stated that she quite often frequented the Portside tavern, Port Pirie to have coffee weekly with her friends.

When leaving the Portside Tavern, Port Pirie I got into my vehicle and discovered that it would not start. I sighted two younger men entering the Portside Tavern, Port Pirie and I followed them into the establishment seeking assistance to start my vehicle.

The two younger men encouraged me to sit with them to have a drink while I waited for them to assist me. I sat with the two younger men in the beer garden at the Portside Tavern. One of the younger men introduced himself as "Mat" and stated that he resided in Western Australia but was in Port Pirie on holidays. (Unusual destination for tourism)

Mat proceeded to make sexual advances and became rude in nature (arrogant and aggressive)

I became defensive and stated that I did not like his behaviour, course of conversation and that I was leaving. Mat then reached across the table and grabbed my wrist and stated "Don't you want this then" and reached down to his pants and undid his zipper and exposed himself indecently. Nudity of genitals.

I became angry with him and called him a rude pig and got up to leave. Mat stood up from the table and grabbed my arm. I reached out with my other hand to slap his face to make him let me go. Mat defended himself and slammed my hand down onto the table aggressively and would not let me go before pushing me backwards. I fell to the ground.

A woman that was sitting on the other table in the beer garden jumped on top of me and was going to fight me (hurt me). I grabbed the back of her hair and the woman froze. The woman's friend yelled at me "Let her go, let her go"

I let go of the woman that was on top of me and was rushed inside to the Portside Tavern and told to get in the Taxi that was waiting for me.

That evening I took photographs of the bruising I suffered to my hands and wrists from the conflict of the attack.

Two weeks later I entered the Port Pirie Police Station to report the incident and get police assistance.

I was taken into an interview room and spoke to Detective Leigh Gwilym - BSGT 72048

Detective Leigh Gwilym stated that he was not able to investigate this matter because ;
"I can't investigate as there's police officers involved"

Detective Leigh Gwilym informed me that he was unable to investigate the report I made on the incident at the Portside Tavern, Port Pirie as the Security Footage was not working that day (Repeated pattern of denied security footage at the Portside Tavern, Port Pirie)
Managers Brad and Janette - Knowledge

Detective Leigh Gwilym then proceeded to state two days after I reported the incident that the witness's he questioned in relation to this incident had conflicting stories to mine.

In question : Security footage was not obtained to know who was in the beer garden to question as witnesses.

I was in the beer garden not inside the establishment where the employee's of the establishment were working - no witnesses

Who did Detective Leigh Gwilym know who to question?

The only witnesses to this event were myself, Mat, his friend and the two other women sitting at the other table, not on security footage as it was not working on the day.

The Fraudulent and malicious Activity continued and escalated.

I requested a change of mobile phone number with the account still having Restricted Access applied. Joshua Adams proceeded to change the mobile phone number and did a check to ensure that the new number that I had been given was a newly created number that had not been circulated before my use, to ensure that the same activity would not occur and if it did would be seen as suspicious activity continued.

On the 25/03/2021 I reported the Fraudulent Malicious activity to Isobelle Oppeloar, Manager, Telstra Store, Kadina who proceeded to file a report to a higher authority, requesting an investigation with the higher authority of the Fraud Division or CEO of Telstra, due to ongoing issues over a 10 year period of continuous Fraudulent Activity. - Refer to Letter addressed to Isobelle Oppeloar, Manager - Refer to document filed report and Case ID number
I received contact from Telstra higher authority but missed the call and am waiting for the second contact, to ring me back as informed in the voice recorded message left on my mobile phone to discuss the issue.

On the 13th April 2021 I sent a letter addressed to the CEO of Telstra Head Office, Mr Andrew Penn, Melbourne, Victoria from the Norwood Post Office branch, Adelaide informing the CEO of the continuous Fraudulent Malicious Activity that had been occurring in my personal and newly created business account with Restricted Access, and requested a thorough investigation into the activity and provided the documented evidence of the activity that had been occurring in all servers and over a long period of time, and following re-location and change of details Refer to letter addressed to CEO - Mr Andrew Penn - Telstra Head Office, Melbourne

I was informed that the reports that had been submitted over a 10 year period in Telecommunication Systems concerning continuous ongoing Fraudulent Activity in my accounts, following Restricted Access applied, change of phone numbers, change of details personal and business, change of servers and relocation was identified as Government and Police Sources Remotely Accessing servers, accounts and computer hardware to result in the Fraudulent activity that had been occurring, which included blocked contact, altered and blocked messages, blocked access to internet services, websites and contacts, impersonating of companies, unusual messages and phone calls from unknown people, blocked contact and altered messages to my children, as informed by my children and resulted in isolation in 2014 - 2016 Extreme Sexual Targeting, Police Targeting and detention. This information confirmed the details obtained in 2016 Origin Electricity account that incurred an Excessive Rise in billing that remained unexplained and resulted in the barcode being scanned as a Police Source causing the Fraudulent Activity. Townsville CC Parking Fines (Queensland Police Source).

I informed Officer Leong that the accounts were set up by the Commonwealth Bank Manager, Paul Flavel, Kadina and could be confirmed by Paul Flavel, Manager.

Following providing my bank account details I informed Officer Leong that this was a case of Identity Theft. Officer Leong agreed with me on the case of Identity Theft and informed me that the case would be referred to Federal Agencies - Federal Police - Legal Investigation.

Officer Leong then informed me that my bank accounts and Tax file number would not be subjected to a suspension and the case would be referred to the Federal agencies for a thorough investigation and I was not instigated in the illegal activity that had occurred because of the Identity Theft - Legal Investigation.

I have not received an email from Officer Leong concerning this matter and contact.

As confirmed by Telstra Head office, concerning continuous Fraudulent Activity occurring in all accounts over a 10 year period, the source of the continuous Fraudulent Activity in every account, server has been a result of Remote Access to servers, accounts and Computer Hardware resulting in blocked access, blocked contact, altered details and Fraudulent Activity and has been conducted by Government and Police Sources Government and Police Targeting over a 27 year period resulting in Specific Targeting of an Individual by the use of Technology - Illegal Government and Police Surveillance, and shared surveillance from location to location, and following relocation

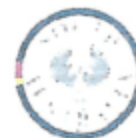

* I asked Adjunct Professor Belinda Moyes, Chief Executive Officer, Country Health SA Local Health Network (CHSA), who is responsible for Port Pirie Regional Health Service (PPRHS), to consider your offer and I am advised as follows:

As Ms [REDACTED] may be aware, the PPRHS already provides consulting room facilities for some specialties identified through consultation with the local general practitioners.

In these instances, PPRHS pays the travel allowance and provides hospital accommodation for visiting specialists providing medical inpatient services.

PPRHS also distributes monthly information to all doctors and health units within the town and surrounding area of the specialists' visiting dates and the waiting times to see new patients.

* The completed Port Pirie GP Plus Health Care Centre, scheduled for September 2013, will also have capacity to provide additional consulting space, if needed. The nature of what additional medical services may be required is yet to be determined.

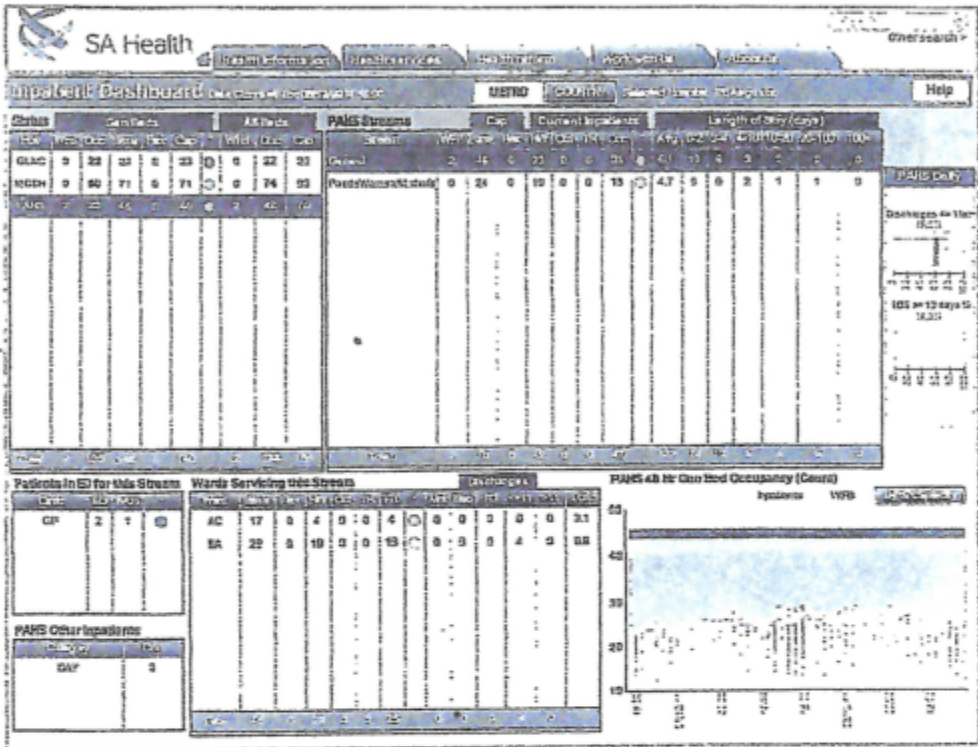

44. After the court hearing the practitioner rang Ms [REDACTED] to ask if she wanted any assistance with getting her licence back. Ms [REDACTED] refused such assistance and hung up on the practitioner.
45. Later this day, the practitioner rang the Law Society's Ethics and Practice Unit to get advice on whether s 269W did enable her to continue to act, even though Ms [REDACTED] was trying to terminate her services. She was given the names of 3 barristers who she could contact for advice. She rang the chambers of one barrister and was asked to ring back after the long weekend.
46. She did, but he was not available to speak with her. She then rang Anthony Crocker at Jeffcott Chambers. He made a time to see her on 17 March 2016.
47. Mr Crocker advised that the practitioner should prepare a letter to Ms [REDACTED] which he would settle. This letter was to explain why she was concerned about the welfare of Ms [REDACTED] and why she had acted as she did.
48. The practitioner prepared such a draft letter and sent it to Mr Crocker on 22 March 2016.
49. On the same day, the practitioner rang Hellene at Forensic Mental Health to ascertain the date of the assessment in order to include that in any letter to be sent to Ms [REDACTED]. The practitioner was advised no request for such an assessment had yet been received from the court. The practitioner sent an email to the CAA enquiring as to the status of the request. She received a response to the effect there was a problem with the next court attendance date.
50. 23 March 2016: the practitioner received a response from Mr Crocker and an amended draft letter. It became apparent from the amendments made by Mr Crocker that he was under the impression that Ms [REDACTED] was expressing a wish to terminate instructions (rather than having done so) and that the concern of the practitioner was whether she could do so, notwithstanding the concerns raised by the GP. That draft letter was never sent because other events intervened. *ADMISSION - LAWYER INVOLVEMENT / DETAINMENT

Findings of the Tribunal

1. [REDACTED] has a mental illness.
2. Because of the mental illness, [REDACTED] requires treatment for her own protection from harm (including harm involved in the continuation or deterioration of her condition) or for the protection of others from harm. - CONFLICTING
3. There are facilities and services available for appropriate treatment of the illness.
4. There is no less restrictive means than a community treatment order of ensuring appropriate treatment of the illness.

Orders of the Tribunal

1. [REDACTED] will be given treatment for her mental illness of a kind authorised by a psychiatrist or authorised medical practitioner who has examined the person.
2. Treatment may be given under the order despite the absence or refusal of consent to the treatment.
3. The treatment and care of [REDACTED] is to be governed by a treatment and care plan.
4. This order does not permit prescribed psychiatric treatment within the meaning of the Mental Health Act 2009 or prescribed treatment within the meaning of the Guardianship and Administration Act 1993.
5. [REDACTED], the applicant and any other person entitled to can apply to the Tribunal to vary or revoke the order at any time.



* 6. Order commences on Tuesday 14 February 2017.

7. Note: As a result of this order, and if required, an authorised officer or police officer may take [REDACTED] into the officer's care and control for the purpose of transport to a treatment centre or other place for medical examination or treatment in accordance with the provisions of the Mental Health Act 2009.

8. Order expires at 2pm on Tuesday 13 February 2018.
