**Reported Illegal Activity involving Identity Theft of the targeted victim**

- Identity Theft involving Australian Tax File numbers, Banking Credentials, Personal Identification
- Up to 1 million dollars of illegal monies in numerous bank accounts in numerous locations of Australia, including Queensland
- Drug Trafficking
- Money Laundering
- **Illegal Money Transfers Involving a Corporation "TELCO" - GOVERNMENT**
- Australian Tax File number being Misused in Australia
- Identity Theft - Numerous Bank accounts opened under the name of the targeted victim of the Identity Theft

The targeted victim was contacted on the 21st May 2021 by Officer Leong stating that she was from Services SA, contact number: 0422 370 133. During this phone contact the targeted victim was informed that the phone call was being recorded and the information was not to be shared with a third party during the recorded phone call.

Officer Leong, a woman officer informed the targeted victim that she had contacted her because of an issue concerning the suspicion of Identity Theft of the targeted victim, which involved numerous bank accounts being opened in the targeted victims stolen identity and being used for illegal purposes of Drug Trafficking, Money laundering, illegal Money Transfers involving a Corporation **TELCO**, and Fraudulent Activity, and were operating in numerous locations of Australia including Queensland and Banking Institutions ANZ and NAB, and involved over 1 through the bank accounts created under the act of the stolen Identity of the targeted victim. The targeted victim was then informed that her Australian Tax File number was being illegally Misused in Australia and that her Bank accounts and Tax file number would be suspended.

Officer Leong, Service SA proceeded to question the targeted victim concerning her current Banking Institutions and balances of the accounts. The targeted victim provided the requested information to Officer Leong and informed her of the Banking Institutions and the name of the Manager who had set up the bank accounts for her and could be confirmed by contacting the details of the Bank Manager provided.

Following providing the details of her Banking Institutions and bank accounts to Officer Leong and stating that this reported activity was obviously a case of Identity Theft, Officer Leong agreed with the contacted Targeted victim that this was a case of Identity Theft and that the case would be referred to Federal Agencies - Federal Police for a Legal Investigation.

Officer Leong then informed the targeted victim that her bank accounts and Australian Tax file number would not be subjected to a suspension and that the targeted victim was not investigated in the illegal activity that had occurred as a result of the Identity Theft and would be subjected to a Legal Investigation by Federal Sources. The targeted victim was informed that she would receive confirmation via her email services. The targeted victim did not receive an email confirmation from Officer Leong concerning this matter.

MUTUAL NON DISCLOSURE AGREEMENT

The Undersigned:

1. JC INNOVATIONS a company under the laws of Australia within the registered office of Australian Business Register, Penrith, NSW, 2740, hereby duly represented by [REDACTED], its Director / Owner.
2. \_\_\_\_\_ an interested party / investor agree to abide by the Australian Intellectual Property Laws upon the disclosure of the business concepts and developments and remain the property of JC INNOVATIONS.

This Mutual Agreement stipulates that either party may be either or both the "Disclosing Party" and / or the "Receiving Party" with information exchanged between the two parties in the course of discussions with the purpose as outlined in Exhibit A and B of this Agreement.

TERMS AND CONDITIONS

Both parties agree as follows;

1. OBLIGATION OF CONFIDENTIALITY  
Each recipient will;
  - 1.1. The business concepts and developments containing Confidential Information will be treated as confidential and will not be disclosed to a third party unless discussed and negotiated with JC INNOVATIONS and is limited to;
    - 1.1.2. Representatives of the recipient who have a need to know and who are bound by an obligation not to disclose Confidential Information otherwise than in accordance with this Agreement.
    - 1.1.3. To consultants, professional advisors or associates of the recipient to whom the Confidential Information is disclosed for the purpose outlined in Exhibit A and B and who owe a duty of Confidentiality to the recipient and are aware of the recipients obligations under this agreement.
    - 1.1.4. The disclosure of the business concepts and developments are subjected to Intellectual Property Law, Australia and remain the property of JC INNOVATIONS unless negotiated and/or discussed with the recipient or interested party involved, pending further legally binding Agreements, Patents, Copyrights necessary or discussed in the developments between both parties.
    - 1.1.5. It is prohibited to copy, share, record or alter the Confidential Information disclosed and is subject to Intellectual Property Law, Australia.
    - 1.1.6. Keep the Confidential Information secure.
    - 1.1.7. On the written request of the disclosure, cease to disclose, copy or use any Confidential Information, or allow it to be disclosed, copied or used.
    - 1.1.8. Cooperate with the disclosure in any reasonable action which it may take to protect the Confidential Information and ensure that all third parties recognised as representatives, professional advisors, associates or to whom the Confidential

Information has been disclosed for any purpose are obligated to this cooperation Agreement in this instance.

- 1.1.9. There are no exceptions to this Agreement and the recipient would be subject to a Breach of Obligations under this Agreement of which Intellectual Property Laws, Australia will apply.

## 2. EXCLUSIONS

- 2.1. The obligations in Clause 1 do not apply to Confidential Information which;
  - 2.2.1. Was in the public domain at or after the time it was disclosed by the disclosing party to the receiving party, other than through a Breach of this Agreement.
  - 2.2.2. The recipient can prove it was in its lawful possession prior to disclosure by the disclosure and which was not acquired directly or indirectly from the disclosure or a third party under an Obligation of Confidentiality.
  - 2.2.3. Required to be disclosed by law or applicable legal processes, provided that the recipient;  
To the extent permitted by law or applicable legal processes, immediately notifies the disclosure of any such request where possible before, or as soon as practicable after, making the disclosure.

## 3. RETURN OR DESTRUCTION

- Immediately upon termination or expiry of this Agreement, the decision by either party not to enter into a Business or Development Agreement contemplated within the disclosure of the Confidential Information, a request by the disclosure at any time, the recipient by the disclosure will;
- 3.2.1 Promptly return to the disclosure, or if directed by the disclosure destroy, all Confidential Information of the disclosure and all documents and other tangible materials containing any such Confidential Information, including disclosed information held by any third party recognised as representatives, professional advisors, associates or to whom Confidential Information has been disclosed.
  - 3.2.2 The recipient will certify compliance with any directions of the disclosure's to destroy Confidential Information within 14 days of receipt of such direction.

## 4. RISK MANAGEMENT

- 4.2. Each party (the first party) will be liable to the other party for any act or omission of any third party to which the first party disclosed the Confidential Information, as if those acts or omissions were the first parties own.
- 4.3. Nothing in this Agreement is intended to grant any rights under any Patent, Trade
- 4.4. Secrets or Copyrights of either party to the other, nor shall this Agreement grant the receiving party any right in or to the Confidential Information of the disclosing party, except the limited right to review such Confidential Information solely in connection with the Business Purpose as described in Exhibit A and B.
- 4.5. The recipient agrees that the disclosure assumes no responsibility or liability for the recipients use of the Confidential Information, and that the disclosure gives no warranty that the Confidential Information will meet the recipients requirements as outlined in Exhibit A and B, Business Purpose or it will be sufficient or suitable for the recipients authorised purposes.
- 4.6. This Agreement may be modified in writing, executed only by authorised representatives of each party and approved only by the disclosure of the Confidential Information.
- 4.7. The disclosure is entitled to seek relief both at law and equity and remedies including (without limitation) injunctive relief and specific performance in the event of any Breach or anticipated Breach of this Agreement, without having to prove any actual damage.
- 4.8. This Agreement will be governed by the laws of Australia. Both parties agree that any dispute, controversy or claim arising out of or in connection with this Agreement, or

Breach, Termination or Invalidity thereof, shall be settled by the relevant tribunal in Australia.

5. TERM

- 5.1 The effective commencement date of this Agreement will be the time stated on this Agreement and prior to the first disclosure of the Confidential Information and the Agreement will remain in force and Legally Binding for the term.
- 5.2 Whether or not the contemplated business relationship between the parties is consummated, the covenants containing to Confidentiality including all third parties recognised as representatives, professional advisors, associates or to whom Confidential Information has been disclosed, shall remain in force and effect for a period of 10 years from the last disclosure of the Confidential Information from one party to the other.
- 5.3 Unless the disclosing party expressly agrees in writing to release all or part of its Confidential Information from the restrictions imposed and stipulated within this Agreement before such period has elapsed this Agreement remains in force and is Legally Binding.

6. GENERAL

- This Agreement and the Exhibit attached hereby constitutes the entire Agreement between the parties with respect to the subject matter hereof, and replaces all oral or written prior communications and Agreements between the parties.
- 6.1 All clauses or part of a clause will be enforceable and applied in the jurisdiction of Australia and legal proceedings will not be sought in a jurisdiction of which all legal stipulations of this Agreement are not enforceable.
- 6.2 A waiver by a party in respect of a Breach of a provision of this Agreement must be given in writing and will not constitute a waiver of any other Breach.
- 6.3 Nothing in this Agreement constitutes a relationship of employer and employee, principal and agent, or trust, or partnership between the parties. Neither party has authority or power to bind the other party.
- 6.4 This Agreement may be signed electronically.
- 6.5 Any notice given under this Agreement must be in writing and may be served by email to the address provided in the details, or any other address that is subsequently notified.
- 6.6 Australian law applies to this Agreement and proceedings must be commenced in the courts of Australia or the registry of the Federal Court of Australia.

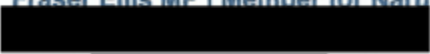

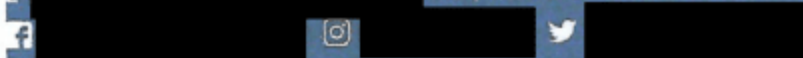

FEDERAL Assistant Minister for Community Housing, Services Luke Howarth and Member for Grey Rowan Ramsay visited Kadiina on Tuesday, September 29.

The pair met with Copper Coast Council mayor Roslyn Talbot, YP Community Transport general manager David McDonald and Copper Coast Salvation Army Captain Karen Armstrong to talk about community housing, mental health and homelessness on Yorke Peninsula.

"Everyone needs to understand a lot of homelessness in the area is situational and if we give people the required help when they need it, they can

"Salvation Army will also contribute \$5m and build more community housing," he said.

"We know homelessness is a lot of people either couch surf or live with other people causing severe overcrowding.

"We'd love to see this government money come into regions — being here (in regions) is a great way to talk to community groups and service providers to better work together."

Mrs Talbot said the visit was an opportunity to highlight for affordable housing in the area. "While it (homelessness) isn't a core function of council, he (Mr Howarth) has given us some suggestions of ways to advocate for solutions for our area," she said.

"We are a growth area and we are trying to encourage more people here but affordable housing is a real issue.

"I also highlighted the need for accessible information for people, to have more Copper Coast-specific connections." Mrs Armstrong said she wanted the assistant minister to know the region had a lack of

Jeffrey Edward Epstein (/ˈɛpstiːn/ EP-steen;<sup>[2]</sup> January 20, 1953 – August 10, 2019) was an American financier and convicted sex offender.<sup>[3][4]</sup> Epstein, who was born and raised in Brooklyn, New York City, began his professional life by teaching at the Dalton School in Manhattan, despite lacking a college degree. After his dismissal from the school, he entered the banking and finance sector, working at Bear Stearns in various roles; he eventually started his own firm. Epstein developed an elite social circle and procured many women and children; he and some of his associates then sexually abused them.<sup>[5][4][6][7]</sup>

In 2005, police in Palm Beach, Florida, began investigating Epstein after a parent complained that he had sexually abused her 14-year-old daughter.<sup>[8]</sup> Epstein pleaded guilty and was convicted in 2008 by a Florida state court of procuring a child for prostitution and of soliciting a prostitute.<sup>[5][9]</sup> He served almost 13 months in custody, but with extensive work release. He was convicted of only these two crimes as part of a controversial plea deal; federal officials had identified 36 girls, some as young as 14 years old, whom Epstein had allegedly sexually abused.<sup>[1][10]</sup>

Epstein was arrested again on July 6, 2019, on federal charges for the sex trafficking of minors in Florida and New York.<sup>[11][12]</sup> He died in his jail cell on August 10, 2019.<sup>[13]</sup> The medical examiner ruled the death a suicide.<sup>[14]</sup> Epstein's lawyers have disputed the ruling, and there has been significant public skepticism about the true cause of his death, resulting in numerous conspiracy theories.<sup>[15][16]</sup> Since Epstein's death precluded the possibility of pursuing criminal charges against him, a judge dismissed all criminal charges on August 29, 2019.<sup>[17][18]</sup> Epstein had a decades-long association with the British socialite Ghislaine Maxwell, leading to her 2021 conviction on U.S. federal charges of sex trafficking and conspiracy for helping him procure girls, including a 14-year-old, for child sexual abuse and prostitution.<sup>[19][20][21][22]</sup> Epstein also maintained long-term relationships with various high-profile individuals, including Donald Trump, Leslie Wexner, Bill Clinton, Alan Dershowitz, and Prince Andrew, Duke of York.<sup>[23]</sup>

A similar \$50-million suit was filed in March 2008, by a different woman, who was represented by the same lawyer.<sup>[129]</sup> These and several similar lawsuits were dismissed.<sup>[130]</sup>

All other lawsuits have been settled by Epstein out of court.<sup>[131]</sup> Epstein made many out-of-court settlements with alleged victims.<sup>[130]</sup>

DESTRUCTION OF CAREER FOR SEX DEMAND - SEXUAL ABUSE RING  
Victims' rights: Jane Does v. United States (2014) \* SEXUAL ABUSE RING - AMERICA  
PROMINENT POSITIONS - AUST. CIV.

A December 30, 2014, federal civil suit was filed in Florida by Jane Doe 1 [redacted] and Jane Doe 2 against the United States for violations of the Crime Victims' Rights Act by the U.S. Department of Justice's NPA with Epstein and his limited 2008 state plea. There was a later unsuccessful effort to add [redacted] (Jane Doe 3) and another woman (Jane Doe 4) as plaintiffs to that case.<sup>[132]</sup> The addition accused Alan Dershowitz of sexually abusing a minor, Jane Doe 3, provided by Epstein.<sup>[133]</sup> The allegations against Dershowitz were stricken by the judge and eliminated from the case because he said they were outside the intent of the suit to re-open the plea agreement.<sup>[134][135]</sup> A document filed in court alleges that Epstein ran a "sexual abuse ring", and lent underage girls to "prominent American politicians, powerful business executives, foreign presidents, a well-known prime minister, and other world leaders".<sup>[136]</sup>

This long-running lawsuit is pending in federal court, aimed at vacating the federal plea agreement on the grounds that it violated victims' rights.<sup>[137]</sup> On April 7, 2015, Judge Kenneth Marra ruled that the allegations made by alleged victim [redacted] against Prince Andrew had no bearing on the lawsuit by alleged victims seeking to reopen Epstein's non-prosecution plea agreement with the federal government; the judge ordered that allegation to be struck from the record.<sup>[134]</sup> Judge Marra made no ruling as to whether claims by [redacted] are true or false. Though he did not allow Jane Does 3 and 4 to join the suit, Marra specifically said that [redacted] may later give evidence when the case comes to court.<sup>[138]</sup>

On February 21, 2019, in the case of *Two Jane Does v. United States*, Senior Judge of the U.S. District Court for the Southern District of Florida Kenneth Marra said federal prosecutors violated the law by failing to notify victims before they allowed him to plead guilty to only the two Florida offenses. The judge left open what the possible remedy could be.<sup>[139]</sup>

[redacted] v. Epstein (2015)

In a December 2014 Florida court filing by Bradley Edwards and Paul G. Cassell meant for inclusion in the Crime Victims Rights Act lawsuit,<sup>[140]</sup> [redacted] (then known as [redacted]), alleged in a sworn affidavit that at age 17, she had been sexually trafficked by Epstein and Ghislaine Maxwell for their own use and for use by several others, including Prince Andrew<sup>[141]</sup> and retired Harvard Law professor Alan Dershowitz.<sup>[8][142]</sup> [redacted] also claimed that Epstein, Maxwell and others had physically and sexually abused her.<sup>[143]</sup> She alleged that the FBI may have been involved in a cover-up.<sup>[144]</sup> She said she had served as Epstein's sex slave from 1999 to 2002, and had recruited other underage girls.<sup>[145]</sup> Prince Andrew, Epstein, and Dershowitz all denied having had sex with [redacted]. Dershowitz took legal action over the allegations.<sup>[146][147][148]</sup> [redacted] filed a defamation suit against Dershowitz,

Details of a civil lawsuit, made public in January 2015, contained a deposition from "Jane Doe 3" that accused Maxwell of recruiting her in 1999, when she was a minor, and grooming her to provide sexual services for Epstein.<sup>[22]</sup> A 2018 exposé by Julie K. Brown in the *Miami Herald* revealed Jane Doe 3 to be [REDACTED], who was previously known as [REDACTED]. [REDACTED] met Maxwell at Donald Trump's Mar-a-Lago Club in Palm Beach, Florida, when [REDACTED] was a 16-year-old spa attendant.<sup>[22]</sup> She asserted that Maxwell had introduced her to Epstein, after which she was "groomed by the two [of them] for his pleasure, including lessons in Epstein's preferences during oral sex".<sup>[22][63]</sup>

Maxwell has repeatedly denied any involvement in Epstein's crimes.<sup>[51]</sup> In a 2015 statement, Maxwell rejected allegations that she has acted as a procurer for Epstein and denied that she had "facilitated Prince Andrew's [alleged] acts of sexual abuse". Her spokesperson said "the allegations made against Ghislaine Maxwell are untrue" and she "strongly denies allegations of an unsavoury nature, which have appeared in the British press and elsewhere, and reserves her right to seek redress at the repetition of such old defamatory claims".<sup>[58][64]</sup>

[REDACTED] asserted that Maxwell and Epstein had trafficked her and other underage girls, often at sex parties hosted by Epstein at his homes in New York, New Mexico, Palm Beach, and the United States Virgin Islands. Maxwell called her a liar. [REDACTED] sued Maxwell for defamation in federal court in the Southern District of New York in 2015. While details of the settlement have not been made public, in May 2017 the case was settled in [REDACTED] favour,<sup>[65]</sup> with Maxwell paying [REDACTED] "millions".<sup>[66]</sup>

In 2017, [REDACTED] filed a suit, in the United States District Court for the Southern District of New York, against Epstein and Maxwell, alleging that Maxwell hired her to give massages to Epstein and later threatened to physically harm her or destroy her career prospects if she did not comply with their sexual demands at his mansion in New York and on his private Caribbean island, Little Saint James. The suit was settled in 2018 under undisclosed terms.<sup>[9][48][67][68]</sup>

Affidavit filed by [REDACTED] (2019)

On 16 April 2019, [REDACTED] went public and filed a sworn affidavit in federal court in New York, alleging that she and her 15-year-old sister, [REDACTED], had been sexually assaulted by Epstein and Maxwell in separate locations in 1996. [REDACTED] affidavit was filed in support of a defamation suit by [REDACTED] against Alan Dershowitz.<sup>[69]</sup> According to the affidavit, Farmer had met Maxwell and Epstein at a New York art gallery reception in 1995. The affidavit says that in the summer of the following year, they hired her to work on an art project in billionaire businessman Leslie Wexner's Ohio mansion, where she was then sexually assaulted by both Maxwell and Epstein.<sup>[70][71]</sup> [REDACTED] reported the incident to the New York Police Department and the FBI.<sup>[52][72]</sup> Her affidavit also stated that during the same summer, Epstein flew her then 15-year-old sister, [REDACTED], to his New Mexico property where he and Maxwell molested her on a massage table.<sup>[73][74]</sup>

Farmer was interviewed for *CBS This Morning* in November 2019 where she detailed the 1996 assault and alleged that Maxwell had threatened both her career and her life after the assault.<sup>[75]</sup>

[REDACTED] v Epstein's estate, Maxwell, and Jane Does 1-3 (2019)

INTELLECTUAL PROPERTY THEFT - AMERICA INVOLVEMENT IN POSSESSION - MULTIPLE

Epstein attended local public schools, first attending Public School 188, and then Mark Twain Junior High School nearby.<sup>[26]</sup> In 1967, Epstein attended the National Music Camp at the Interlochen Center for the Arts.<sup>[29]</sup> He began playing the piano when he was five.<sup>[30]</sup> He graduated in 1969 from Lafayette High School at age 16, having skipped two grades.<sup>[31][32]</sup> Later that year, he attended classes at Cooper Union until he changed colleges in 1971.<sup>[31]</sup> From September 1971, he attended the Courant Institute of Mathematical Sciences at New York University, but left without receiving a degree in June 1974.<sup>[31][32]</sup>

## Career

### Teaching

Epstein started working in September 1974 as a physics and mathematics teacher for teens at the Dalton School on the Upper East Side of Manhattan.<sup>[31][33]</sup> Donald Barr, who served as the headmaster until June 1974,<sup>[34][35][36]</sup> was known to have made several unconventional recruitments at the time, although it is unclear whether he had a direct role in hiring Epstein.<sup>[33][37][38]</sup> Three months after Barr's departure, Epstein began to teach at the school, despite his lack of credentials.<sup>[38]</sup> Epstein allegedly showed inappropriate behavior toward underage students at the time.<sup>[33][37]</sup> He became acquainted with Alan Greenberg, the chief executive officer of Bear Stearns, whose son and daughter were attending the school. Greenberg's daughter, Lynne Koepfel, pointed to a parent-teacher conference where Epstein influenced another Dalton parent into advocating for him to Greenberg.<sup>[35]</sup> In June 1976, after Epstein was dismissed from Dalton for "poor performance",<sup>[33][39][40]</sup> Greenberg offered him a job at Bear Stearns.<sup>[30][41]</sup>

### Banking

Epstein joined Bear Stearns in 1976 as a low-level junior assistant to a floor trader.<sup>[42]</sup> He swiftly moved up to become an options trader, working in the special products division, and then advised the bank's wealthiest clients, such as Seagram president Edgar Bronfman, on tax mitigation strategies.<sup>[32][43][44]</sup> Jimmy Cayne, the bank's later chief executive officer, praised Epstein's skill with wealthy clients and complex products. In 1980, four years after joining Bear Stearns, Epstein became a limited partner.<sup>[42]</sup>

In 1981, he was asked to leave Bear Stearns for, according to his sworn testimony, being guilty of a "Reg D violation".<sup>[45][32][30]</sup> Even though Epstein departed abruptly, he remained close to Cayne and Greenberg and was a client of Bear Stearns until its collapse in 2008.<sup>[42]</sup>

### Financial consulting

In August 1981, Epstein founded his own consulting firm, Intercontinental Assets Group Inc. (IAG),<sup>[46]</sup> which assisted clients in recovering stolen money from fraudulent brokers and lawyers.<sup>[30]</sup> Epstein described his work at this time as being a high-level bounty hunter. He told friends that he worked sometimes as a consultant for governments and the very wealthy to recover embezzled funds, while at other times he worked for clients who had embezzled funds.<sup>[30][47]</sup> Spanish actress and heiress Ana Obregón was one such wealthy client, whom Epstein helped in 1982 to recover her father's millions in lost investments, which had disappeared when Drysdale Government Securities collapsed because of fraud.<sup>[48]</sup>

Liquid Funding was initially 40 percent owned by Bear Stearns. Through the help of the credit rating agencies – Standard & Poor's, Fitch Ratings and Moody's Investors Service – the new bundled securities were able to be created for companies so that they got a gold-plated AAA rating. The implosion of such complex securities, because of their inaccurate ratings, led to the collapse of Bear Stearns in March 2008 and set in motion the financial crisis of 2007–2008 and the subsequent Great Recession. If Liquid Funding were left holding large amounts of such securities as collateral, it could have lost large amounts of money.<sup>[65][67]</sup>

## Investments

### Hedge funds

Between 2002 and 2005, Epstein invested \$80 million in the D.B. Zwirn Special Opportunities Fund, a hedge fund that invested in illiquid debt securities.<sup>[68][69]</sup> In November 2006, Epstein attempted to redeem his investment after he was informed of accounting irregularities in the fund.<sup>[70]</sup> By this time, his investment had grown to \$140 million. The D.B. Zwirn fund refused to redeem the investment. Hedge funds that invest in illiquid securities typically have years-long "lockups" on their capital for all investors and require redemption requests to be made in writing 60 to 90 days in advance.<sup>[68]</sup> The fund was closed in 2008, and its remaining assets of approximately \$2 billion, including Epstein's investment, were transferred to Fortress Investment Group when that firm bought the assets in 2009.<sup>[68][69]</sup> Epstein later went to arbitration with Fortress over his redemption attempt. The outcome of that arbitration is not publicly known.<sup>[68]</sup>

MEDICAL BUSINESS PLAN 2006 - 2009 - INTELLECTUAL PROPERTY THEFT  
In August 2006, Epstein, a month after the federal COMMENCEMENT SEXUAL  
investigation of him began,<sup>[71]</sup> invested \$57 million in the Bear TARGETING 2007  
Stearns High-Grade Structured Credit Strategies Enhanced  
Leverage hedge fund.<sup>[68][72]</sup> This fund was highly leveraged in  
mortgage-backed collateralized debt obligations (CDOs).<sup>[72]</sup>

On April 18, 2007, an investor in the fund, who had \$57 million invested, discussed redeeming his investment.<sup>[73]</sup> At this time, the fund had a leverage ratio of 17:1, which meant for every dollar invested there were seventeen dollars of borrowed funds; therefore, the redemption of this investment would have been equivalent to removing \$1 billion from the thinly traded CDO market.<sup>[74]</sup> The selling of CDO assets to meet the redemptions that month began a repricing process and general freeze in the CDO market. The repricing of the CDO assets caused the collapse of the fund three months later in July, and the eventual collapse of Bear Stearns in March 2008. It is likely Epstein lost most of this investment, but it is not known how much was his.<sup>[73][72]</sup>

The government began negotiation with Epstein for a plea agreement in mid-2007, as the hedge fund began to collapse.

By the time that the Bear Stearns fund began to fail in May 2007, Epstein had begun to negotiate a plea deal with the U.S. Attorney's Office concerning imminent charges for sex with minors.<sup>[68][71]</sup> In August 2007, a month after the fund collapsed, the U.S. attorney in Miami, Alexander Acosta, entered into direct discussions about the plea agreement.<sup>[71]</sup> Acosta brokered a lenient deal, according to him, because he had been ordered by higher government officials, who told him that Epstein was an individual of importance to the government.<sup>[52][53]</sup> As part of the negotiations, according to the *Miami Herald*, Epstein provided "unspecified information" to the Florida federal prosecutors for a more lenient sentence and was supposedly an unnamed key witness for the New York federal prosecutors in their unsuccessful June 2008 criminal case against the two managers

John Wayne Olsen, Liberal Party Premier of South Australia 1996-2001, served two years in the Senate from 7 May 1990, when he filled a casual vacancy caused by the resignation of Senator Tony Messner.

A colourful backgrounder in the *Australian* on 29 November 1996, the day after he became Premier of South Australia, argued that there was a defining moment in Olsen's life when he was eighteen and with his father when the latter suffered a massive heart attack and died while driving the family speedboat. Other defining moments revolved around his fortunes as a state politician; his two years in the Senate rated barely a mention. State politics was clearly the main game for John Olsen.

Born in Kadina in rural South Australia on 7 June 1945, Olsen was the son of Stanley John Olsen, owner of an agricultural machine and motor vehicle business, and his wife Joyce Rosalind, nee Heath. He was educated at Kadina Memorial High School, studied accountancy at the South Australian School of Business Studies, spent a

period from 1962 as a bank clerk with the SA Savings Bank, and by 1968 was managing director of the family business, J. R. Olsen & Sons Pty Ltd. His determination to be part of the political process and influence policy direction was inspired by what he saw as the need to address the neglect of small business interests under Don Dunstan, and 'the excesses of the Dunstan and Whitlam era'. Olsen became politically engaged first as president of South Australia's Rural Youth (1970) and later as Kadina town councillor from 1971 and mayor of Kadina from 1974 to 1977. He was also South Australian president of the Federation of Chambers of Commerce from 1974 to 1976. In May 1968 he married Julie Abbott; they were to have two sons and a daughter.

In 1976 Olsen was elected president of the South Australian division of the Liberal Party, an office which he held until 1979 when he was elected to the South Australian House of Assembly as the member for Rocky River, following a boundary redistribution in 1985 he became the member for Custance. Olsen served as Chief Secretary and Minister for Fisheries in the Tonkin Liberal Government from March 1982 until the ALP victory in the state election in November of that year. David Tonkin resigned from Parliament, and Olsen defeated Dean Brown in a ballot for leadership of the party. As Leader of the Opposition in the South Australian Parliament, he contested and lost the 1986 and 1989 state elections against Labor Premier John Bannon. Following the defeat of November 1989, in which his party obtained more than fifty per cent of the two-party preferred vote, Olsen indicated that he would accept nomination for the Senate vacancy to be caused by the impending resignation of Senator Tony Messner. He resigned as Leader in January 1990, and resigned his seat in the House of Assembly immediately before being chosen for the vacancy by a joint sitting of the Houses of the SA Parliament on 7 May 1990; he was sworn in the Senate on the following day.[1]

Olsen's first speech, delivered on 21 May 1990, called for increased unity for a 'fragmented and nervous nation'. He criticised the regulatory duplication that characterised federal and state administration of health, education and housing, and urged the restructuring of the economy through privatisation and the deregulation of financial and labour markets, to create an environment 'where freedom and incentive are the basics'.

He raised the issue of the maladministration of the Murray-Darling and the impact this was having on South Australia:

... the heart of Australia is being left to die. Its main artery is clogged with the salinity and pollution of the States through which it passes, with my State of South Australia ... condemned by a political inertia to being in effect the sewer of Australia.

And he addressed immigration issues, arguing that migrants should be encouraged to settle in places other than the east coast, that they should be obliged to become citizens, and to take English language courses.[2]

An experienced parliamentarian, during his brief time in the Senate Olsen made 'articulate and forceful, and, at times, emotional' contributions to debate. He spoke often on the state of the economy, particularly its effect on small business and rural communities, and referring frequently to the situation in his home state.

During his premiership Olsen had overseen the privatisation of South Australia's electricity system, the outsourcing of its water industry, and a number of development projects intended to boost the state's ailing economy. After the election, Marshall continued to lead the Liberals in opposition.<sup>[20]</sup> Former Liberal leader Martin Hamilton-Smith became an independent two months after the election and indicated his support for the government.<sup>[21]</sup> Following the death of Such and the subsequent 2014 Fisher by-election which Labor won by five votes from a 7.3% 2PP swing away from the Liberals, Labor went from minority to majority government. Brock and Hamilton-Smith maintained their confidence and supply support for the government which provided a 26 to 21 parliamentary majority.<sup>[22]</sup>

**2018 state election**

The 2018 state election was held on 17 March. The July to September 2014 Newspoll had seen Labor begin to lead the Liberals on the two-party-preferred vote for the first time since 2009.<sup>[23]</sup> The October to December 2015 Newspoll saw Marshall's leadership approval rating drop 11 points to 30%, the equal lowest Newspoll approval rating in history for a South Australian Opposition Leader since Dale Baker in 1990.<sup>[24][25][26]</sup> At the election, Marshall again faced Weatherill and Labor which were seeking a record fifth term in office and the "wild card" centrist party, SA-Best, led by former Senator Nick Xenophon, who was seeking the balance of power in the Assembly. The 2016 electoral redistribution had given the Liberals an advantage of 27 seats to Labor's 20 seats heading into the election. → GOV SOURCES INVOLVED

\*JOHN OLSEN - KADINA - COMMENCEMENT OF TARGETING\*

Four hours after the close of polls on election day, at approximately 10pm ACDST, Weatherill telephoned Steven Marshall and conceded defeat. Marshall was introduced to the election day function by former Liberal Premier John Olsen and claimed victory. The SA Liberals had won the election with 25 seats to Labor's 19, a bare majority of two – the first time the Liberals had won a state election since Olsen's victory in 1997.<sup>[27][28][29][30]</sup> Despite the outcome, there was actually a state-wide two-party-preferred swing away from the Liberals toward Labor.<sup>[31]</sup>

\*CONNECTED TO STEVEN MARSHALL - CONSPIRING AGAINST TARGETED VICTIM IN 2020 WITH VICKIE CHAPMAN, SA ATTORNEY GENERAL, Premier of South Australia

Two days after the election, with the result beyond doubt even though counting was still under way, Marshall had himself, deputy leader Vickie Chapman, and Father of the South Australian Parliament Rob Lucas sworn in as an interim three-person government by the Governor of South Australia, Hieu Van Le. Marshall became Premier, Chapman Deputy Premier and Attorney-General, and Lucas Treasurer. Lucas had previously served as Treasurer in the last Liberal government.<sup>[32]</sup> The full ministry was sworn in on 22 March.<sup>[33]</sup> In addition to serving as Premier, Marshall retained responsibility for portfolio areas of The Arts, Aboriginal Affairs and Reconciliation, Defence and Space Industries, Veterans' Affairs and Multicultural Affairs, although these were no longer named as ministries.<sup>[34]</sup>

Told me that he had bought her a present - a silk scarf - he had also bought a silk scarf for me when we first starting dating - I told him that it was inappropriate and personal and as he had bought one for me does he do that with all the women and I said it was now nothing special and had no special meaning and that I would not now ever wear it. He denied that he was doing anything wrong.

I went to a university conference, Robbie Davies was there, I walked up to join Vincent's PA who was standing with her talking, I was visible to Robbie Davies. She would not look at me and held her head down towards the floor and rushed away quickly, did not say hello or acknowledge me in anyway.

Michelle - Adelaide University - employee

Michelle kept messaging Vincent day and night through personal messaging apps with her personal issues. Contacted Vincent once at 4am in the morning with her personal issues while he was away from the university travelling in the US - He got out of bed to address and support her personal issues.

This went on for months

Would not fire her even though she was submitting wrong results and incompetent at her job - he was letting everyone else go when the grant money ran out but extended her contract.

I told him to back this personal contact off and as her boss his relationship at work should be professional and he was acting inappropriately in a relationship (ours) which was damaging and disrespectful towards me. He denied that he was doing anything wrong. This behaviour stopped.

██████ - Adelaide University - Colleague

Kept getting sms messages at the same time every night when he got home from work - was acting strangely and suspiciously - He never spoke about ██████ to me or mentioned her name. I found his behaviour odd and suspicious and relating to previous behaviour so I checked his sms messages on his tablet that were connected to his phone. I found numerous messages to ██████ - meeting her for lunch constantly - lots of interaction - picking her up from another location of campus in my red car that he had bought for me and telling her that he missed her - I felt Betrayed. - NO REGRETS

I confronted him and told him that I had read the messages on his tablet - He said that it was a joke - seemed nervous and defensive - we argued - told him he was lying to me, hiding things and it was inappropriate behaviour in a relationship, that he was hurting me.

He denied that he was doing anything wrong and blamed me for not trusting him.

Pattern forming - Behavioural - I was aware

He disconnected his phone from the tablet so no sms messages could be seen on it and changed his password when he travelled next.

Saw the messages to ██████ saying he was drinking with the girls and she should come and join him - Denied he was drinking at work and I was being paranoid - he was doing this after he had asked me to stop drinking - I quit for nearly a year - He also asked me to quit cigarettes - I did for nearly 7 months - he was doing this at work while I sat alone at home waiting for him to come home at the end of everyday.

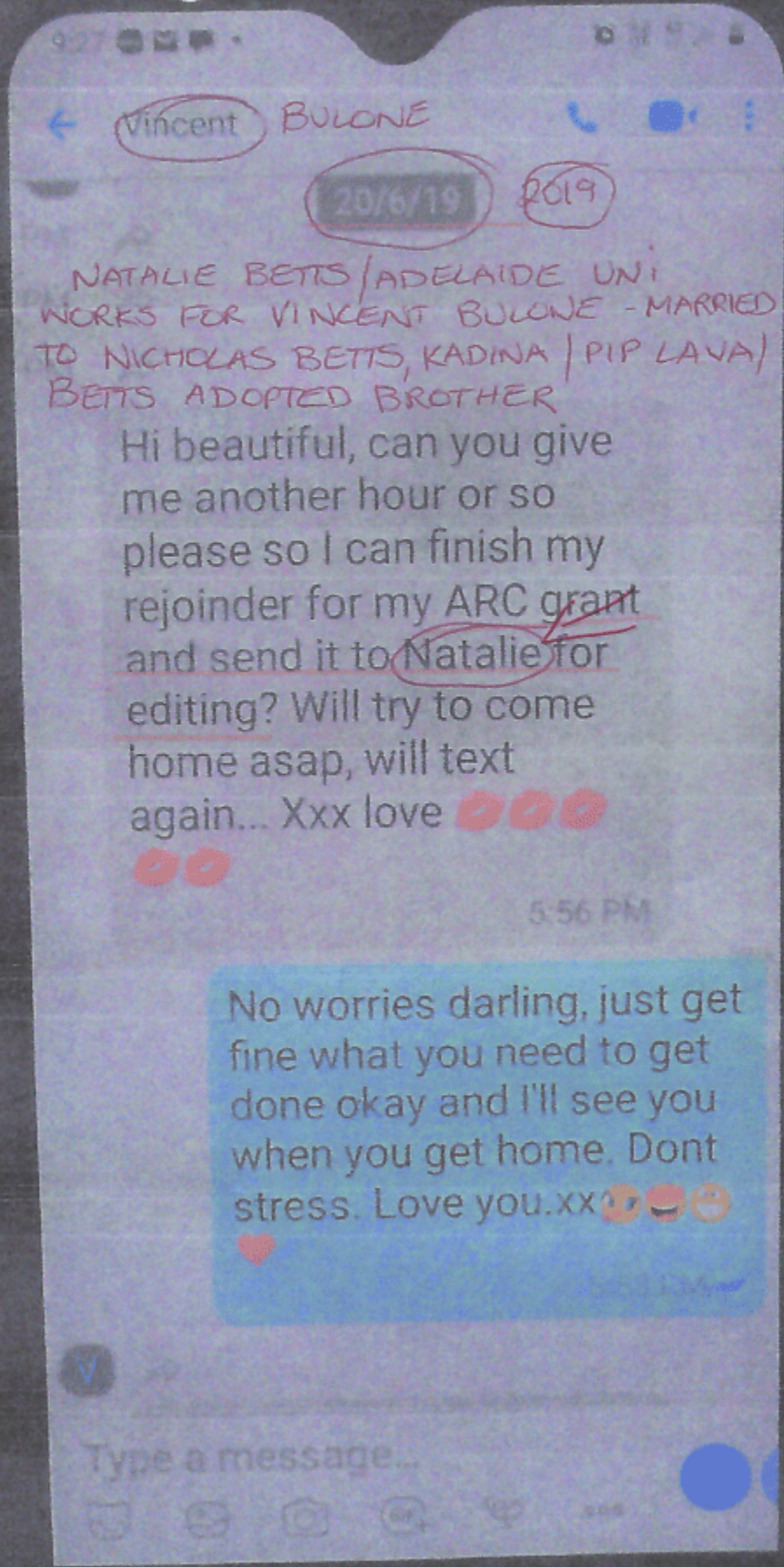

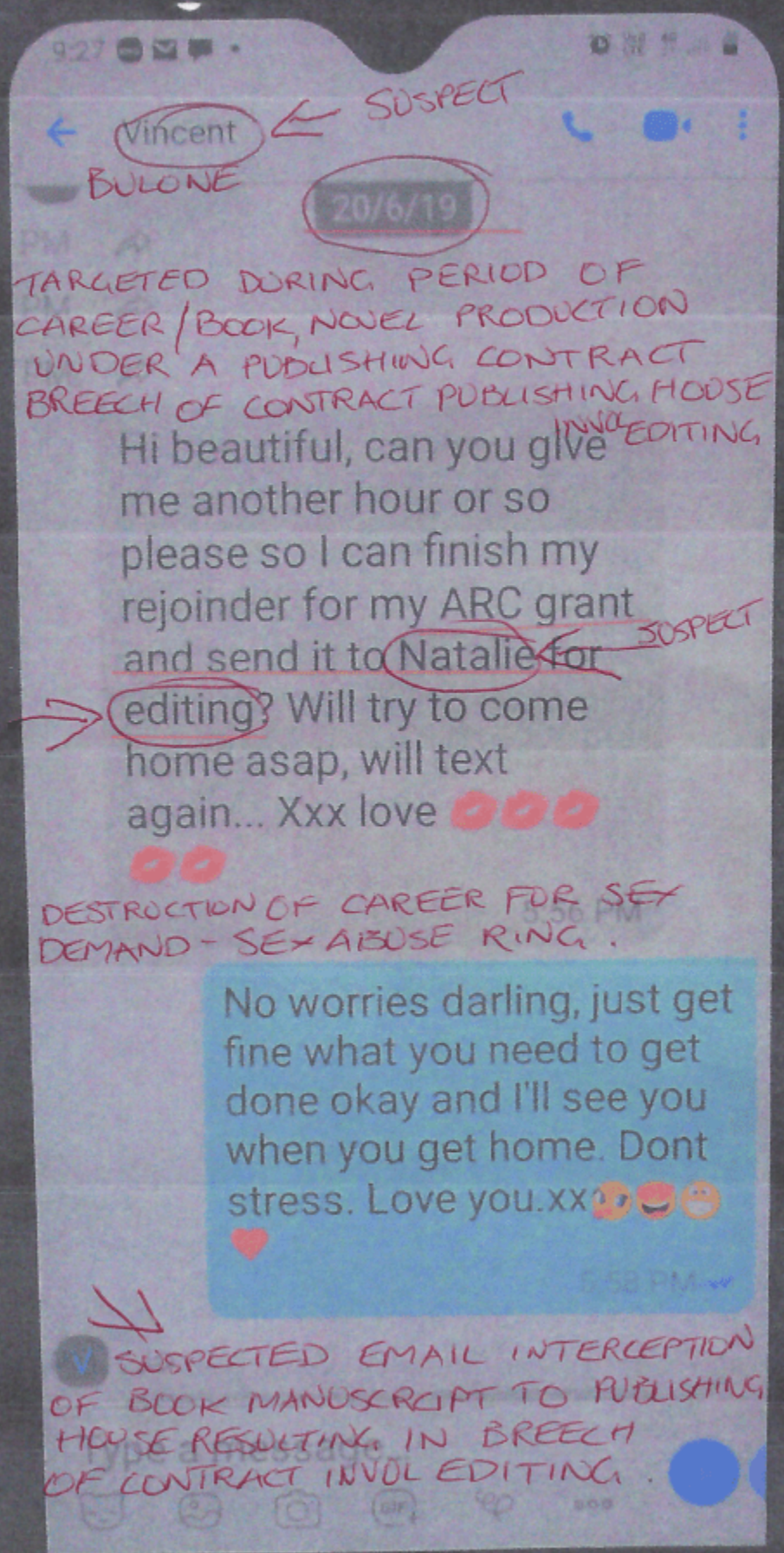

This email is in response to your letter dated 11<sup>th</sup> April 2023 which was forwarded to the Compliance Department to ensure that it is dealt with on priority basis and resolved to the satisfaction of all parties involved. In pursuance thereof, we would like to bring the following to your attention:

Firstly, please be informed that we are a reputable publishing company, working according to the fair business practices and the publication of your client's books have been of immense importance to us as much as it is to her. Therefore, as far as your client's apprehensions regarding Book 1 titled 'Reality' are concerned, please note that throughout the entire process of production, multiple versions of the proof files were sent to her and our coordinators took full account of their suggestions. Only after a lengthy editing process and constant correspondence, we mutually agreed upon a final draft, and thereafter, she signed the Final Proof Certificate which then resulted in the publication of the book.

With regards to the marketing aspect of the same, we are confident upon reviewing the contact sheet that our Marketing Department had pitched the title to multiple prospects and allocated extra time to its marketing campaign. In fact, they tend to constantly use different mediums to pro-actively obtain press and online presence though it remains at the discretion of these prospects whether they wish to provide us with an opportunity for the same. It is sometimes difficult to predict how well any book will do because of ever-changing trends and topics, but we always continue to adjust our approach and reach out, accordingly. Moreover, it is also pertinent to mention Clause 23 of the Publishing Contract here which clearly dictates that we cannot guarantee sales of the Work, as seen below:

**"No representations other than those expressly contained herein will be binding, and this Agreement is entered into in good faith by both parties, it being distinctly understood that neither party has guaranteed, nor intends to nor is able to guarantee, nor is able to predict, the exact sale (if any) of a specific number of copies of the WORK."**

By virtue of this clause, there can be no warranties against the number of sales of the Work published as this rests tangent on matters beyond the control of the Publisher. Also, under the Publishing Contract, the Publisher shall alone have full discretion as to the nature and extent of any promotion and distribution of the Work but shall not be held liable for any outlet, whether distributor or book shop, declining to accept the orders.

Furthermore, your client's concerns regarding Book 2 titled, 'On the Edge of Reality' are quite peculiar, since the work on it was still in progress and according to the communication your client had with the concerned department dated 20<sup>th</sup> December 2021, she not only appeared satisfied but also gave approval for the final version of the shared proof to be sent to the editorial department as well – followed by another one after a couple of months (ref. email dated 12<sup>th</sup> March 2022) asserting that there has been a breach of contract which seemed extremely unreasonable.

On that note, since we have carried out the production process on Book 1 "Reality" and fully complied with the terms and conditions of the contract, your client's demand for a refund for this title is neither justified nor makes her entitled for the same. However, with regards to the request for a refund on Book 2, "On the Edge of Reality", we are of the view that since a considerable amount of work has been done so far and the final files are ready to be shared, your client might want to reconsider her decision and provide us with final feedback so that the production process may be expedited accordingly and the book be published effectively but if your client still wish to continue with the cancellation, we will respect her decision and appreciate that you'd understand that termination of the contract at this stage would lead to a considerable loss for us when we factor in the administrative, production and editorial costs incurred during this entire time, therefore, as a gesture of goodwill, we will only deduct **50%** of the amount paid in terms of the work carried out to-date for this title and refund the remaining **50%** to your client which is **1450 GBP** -- as a result of which your client's contract for book 2 will be terminated and all rights shall be reverted back to them. We believe that we have proposed a reasonable settlement offer so the matter can be concluded.

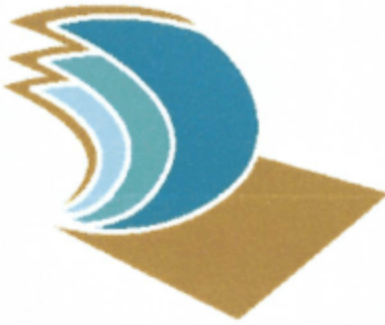

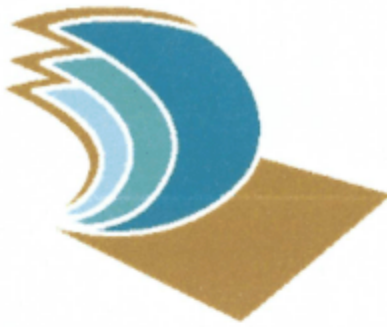

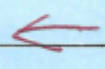
