A similar \$50-million suit was filed in March 2008, by a different woman, who was represented by the same lawyer.^[129] These and several similar lawsuits were dismissed.^[130]

All other lawsuits have been settled by Epstein out of court.^[131] Epstein made many out-of-court settlements with alleged victims.^[130]

Victims' rights: *Jane Does v. United States* (2014)

SEXUAL ABUSE RING
PROMINENT POSITIONS

A December 30, 2014, federal civil suit was filed in Florida by Jane Doe 1 (██████████) and Jane Doe 2 against the United States for violations of the Crime Victims' Rights Act by the U.S. Department of Justice's NPA with Epstein and his limited 2008 state plea. There was a later unsuccessful effort to add ██████████ (Jane Doe 3) and another woman (Jane Doe 4) as plaintiffs to that case.^[132] The addition accused Alan Dershowitz of sexually abusing a minor, Jane Doe 3, provided by Epstein.^[133] The allegations against Dershowitz were stricken by the judge and eliminated from the case because he said they were outside the intent of the suit to re-open the plea agreement.^{[134][135]} A document filed in court alleges that Epstein ran a "sexual abuse ring", and lent underage girls to "prominent American politicians, powerful business executives, foreign presidents, a well-known prime minister, and other world leaders".^[136]


This long-running lawsuit is pending in federal court, aimed at vacating the federal plea agreement on the grounds that it violated victims' rights.^[137] On April 7, 2015, Judge Kenneth Marra ruled that the allegations made by alleged victim ██████████ against Prince Andrew had no bearing on the lawsuit by alleged victims seeking to reopen Epstein's non-prosecution plea agreement with the federal government; the judge ordered that allegation to be struck from the record.^[134] Judge Marra made no ruling as to whether claims by ██████████ are true or false. Though he did not allow Jane Does 3 and 4 to join the suit, Marra specifically said that ██████████ may later give evidence when the case comes to court.^[138]

On February 21, 2019, in the case of *Two Jane Does v. United States*, Senior Judge of the U.S. District Court for the Southern District of Florida Kenneth Marra said federal prosecutors violated the law by failing to notify victims before they allowed him to plead guilty to only the two Florida offenses. The judge left open what the possible remedy could be.^[139]

██████████ **v. Epstein (2015)**

In a December 2014 Florida court filing by Bradley Edwards and Paul G. Cassell meant for inclusion in the Crime Victims Rights' Act lawsuit,^[140] ██████████ (then known as ██████████), alleged in a sworn affidavit that at age 17, she had been sexually trafficked by Epstein and Ghislaine Maxwell for their own use and for use by several others, including Prince Andrew^[141] and retired Harvard Law professor Alan Dershowitz.^{[8][142]} ██████████ also claimed that Epstein, Maxwell and others had physically and sexually abused her.^[143] She alleged that the FBI may have been involved in a cover-up.^[144] She said she had served as Epstein's sex slave from 1999 to 2002, and had recruited other underage girls.^[145] Prince Andrew, Epstein, and Dershowitz all denied having had sex with ██████████. Dershowitz took legal action over the allegations.^{[146][147][148]} ██████████ filed a defamation suit against Dershowitz,

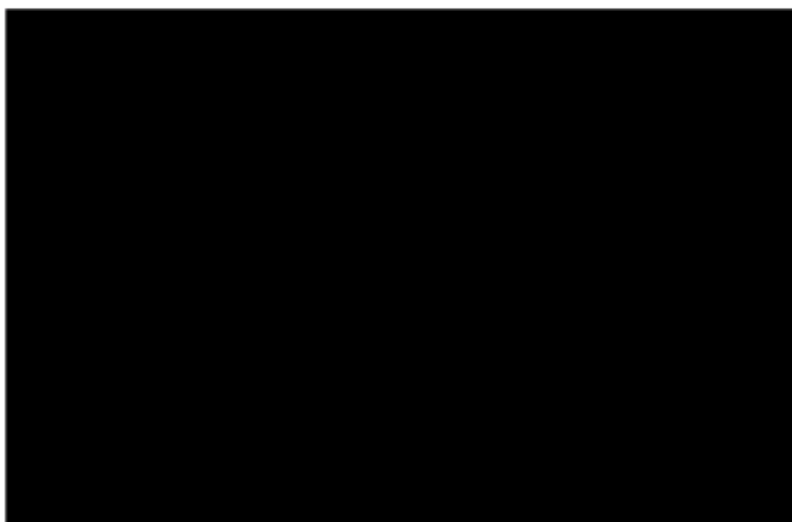

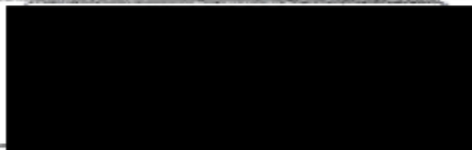

Starting in spring 2020, Trump began to sow doubts about the election, claiming without evidence that the election would be rigged and that the expected widespread use of mail balloting would produce massive election fraud.^{[623][624]} In July Trump raised the idea of delaying the election.^[625] When in August the House of Representatives voted for a \$25 billion grant to the U.S. Postal Service for the expected surge in mail voting, Trump blocked funding, saying he wanted to prevent any increase in voting by mail.^[626] He repeatedly refused to say whether he would accept the results of the election and commit to a peaceful transition of power if he lost.^{[627][628]}



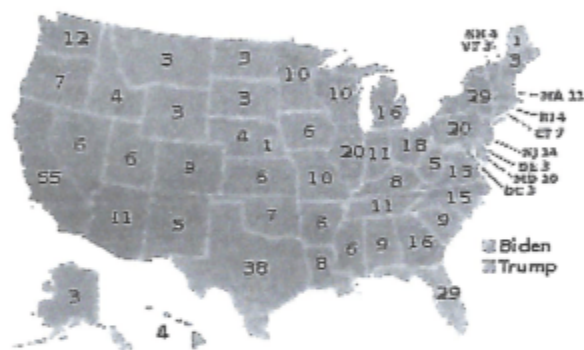

Trump campaign advertisements focused on crime, claiming that cities would descend into lawlessness if Biden won the presidency.^[629] Trump repeatedly misrepresented Biden's positions^{[630][631]} and shifted to appeals to racism.^[632]

Biden won the election on November 3, receiving 81.3 million votes (51.3 percent) to Trump's 74.2 million (46.8 percent)^{[633][634]} and 306 Electoral College votes to Trump's 232.^[635]

Claims of voting fraud, attempt to prevent presidential transition

At 2 a.m. the morning after the election, with the results still unclear, Trump declared victory.^[636] After Biden was projected the winner days later, Trump said, "this election is far from over" and baselessly alleged election fraud.^[637] Trump and his allies filed many legal challenges to the results, which were rejected by at least 86 judges in both the state and federal courts, including by federal judges appointed by Trump himself, finding no factual or legal basis.^{[638][639]} Trump's unsubstantiated allegations of widespread voting fraud were also refuted by state election officials.^[640] After

Cybersecurity and Infrastructure Security Agency (CISA) director Chris Krebs contradicted Trump's fraud allegations, Trump dismissed him on November 17.^[641] On December 11, the U.S. Supreme Court declined to hear a case from the Texas attorney general that asked the court to overturn the election results in four states won by Biden.^[642]

Trump withdrew from public activities in the weeks following the election.^[643] He initially blocked government officials from cooperating in Biden's presidential transition.^{[644][645]} After three weeks, the administrator of the General Services Administration declared Biden the "apparent winner" of the election, allowing the disbursement of transition resources to his team.^[646] Trump still did not formally concede while claiming he recommended the GSA begin transition protocols.^{[647][648]}

The Electoral College formalized Biden's victory on December 14.^[635] From November to January, Trump repeatedly sought help to overturn the results of the election, personally pressuring various Republican local and state office-holders,^[649] Republican state and federal legislators,^[650] the Justice Department,^[651] and Vice President Pence,^[652] urging various actions such as replacing presidential electors, or a request for Georgia officials to "find" votes and announce a "recalculated" result.^[650] On February 10, 2021, Georgia prosecutors opened a criminal investigation into Trump's efforts to subvert the election in Georgia.^[653]

Personal life ^{2013 EASY EDITOR - CRIME}

Gates is an avid reader, and the ceiling of his large home library is engraved with a quotation from The Great Gatsby.^[187] He also enjoys bridge, tennis and golf.^{[188][189]} His days are planned for him on a minute-by-minute basis, similarly to the U.S. president's schedule.^[190] Despite his wealth and extensive business travel, Gates flew coach (economy class) in commercial aircraft until 1997, when he bought a private jet.^[191]

Gates purchased the Codex Leicester, a collection of scientific writings by Leonardo da Vinci, for US\$30.8 million at an auction in 1994.^[192] In 1998, he reportedly paid \$30 million for the original 1885 maritime painting Lost on the Grand Banks, at the time a record price for an American painting.^[193]

In 2016, he revealed that he was color-blind.^[194]

Marriage and divorce

Gates married Melinda French on the Hawaiian Island of Lanai on January 1, 1994.^[195] They met in 1987 after Melinda began working at Microsoft.^[196] At the time of their marriage, Gates was given permission by Melinda to spend limited time with his ex-girlfriend, businesswoman Ann Winblad.^[197] Bill and Melinda have three children: Jennifer, Rory and Phoebe.^[198]

Gates and Melinda, 2009

The family's residence is an earth-sheltered mansion in the side of a hill overlooking Lake Washington in Medina, Washington. In 2009, property taxes on the mansion were reported to be US\$1.063 million, on a total assessed value of US\$147.5 million.^[199] The 66,000-square-foot (6,100 m²) estate has a 60-foot (18 m) swimming pool with an underwater music system, as well as a 2,500-square-foot (230 m²) gym and a 1,000-square-foot (93 m²) dining room.^[200] On May 3, 2021, the Gateses announced they had decided to divorce after 27 years of marriage and 34 years as a couple.^[201] They said they would keep working together on charitable efforts.^{[201][202]} The Wall Street Journal reported that Melinda had been meeting with divorce attorneys since 2019, citing interviews that suggested Bill's ties with Jeffrey Epstein was at least one of her concerns.^[203] The divorce was finalized on August 2, 2021.^[204]

minor injuries but was recovering well. George seemed emotionally upset by his fathers
accident as I spoke to him several times on the phone during that time.**

**One of the phone calls as I tried to call him was diverted to a call centre which I found odd.
George had called me back in relation to the missed call.**

**George Georgio and I made further arrangements in relation to us meeting in person a few
weeks after the events of his fathers car accident. We had made the arrangements via the**

During this time I had relocated from [REDACTED]
[REDACTED] on the 22nd May 2014.

I had been in [REDACTED] for approx. 2-3 months while I got to know George Georgio on the online dating site, RSVP.love.singles

Meeting in Person:

George Georgio informed me that he was flying from Melbourne to Adelaide and I had arranged to pick him up from the Adelaide Airport.

I entered the Adelaide Airport and was told by George Georgio via mobile phone to meet him near Gate 19. I had rang George Georgio on my mobile phone as I could not locate him within the airport and he informed me that I should stand near the shop glass window near the boarding area - shopping area foyer / Book shop

After meeting we left the Adelaide Airport and I drove George Georgio back towards Port Pirie. We stopped at a pub in Lower Light off the highway and stayed for about an hour while we dined and consumed a couple of drinks. George Georgio was very polite and had spoken in detail of his previously owned business dealings with multi million dollar Companies, living a lavish lifestyle and of a previous break down of a relationship that had left him financially hard shipped, had lost everything, of which he had to re-build his life by becoming a teacher and lecturer of machine operating, which he found challenging and enjoyable.

George Georgio had stayed at my place of residence, [REDACTED] for a 2 day period over the weekend. We enjoyed getting to know one another further and enjoyed various activities together within the township, as I believed we were starting a relationship.

Activities over the weekend:

- BH Club, Port Pirie - Playing eightball
- Central Hotel, Port Pirie - Dining / lunch
- Blockbuster Video - Hired movies to watch that evening together

We were served by employee of Blockbuster Video, Port Pirie by Marta Newman and sighted together by this employee.

Marta Newman and I were personally involved / friendship - Phone records

She had asked me after that weekend : "Who was that nice younger man that you were with when you came into Blockbuster?"

During that weekend George Georgio informed me (of which he had not stated during our numerous interactions via mobile phone and email) that he lived with a female whom worked in the Mining Industry, but that they were just good friends. Over the that weekend George Georgio had stayed in constant continuous contact with this woman via text messages and mobile phone contact, which I found to be disrespectful, odd and too close for comfort, in regards to his statement that they were only just friends. I questioned in my mind this interaction - Womanising behaviour / lying

*** SEXUAL ABUSE / RAPE - UNSUSPECTING VICTIM / WITHOUT KNOWLEDGE OR CONSENT OF SEXUAL TARGETING - WITHOUT CONSENT**

On the Sunday morning whilst I slept along side George Georgio in my bed, [REDACTED]
[REDACTED] I was suddenly awoken by the touch of George Georgio having sex with me while I slept and did not have time to react to stop his penetration before he had finished.

A matter of minutes between start and finish of penetration.

*** I had not planned or consented to having sex with George Georgio as I believed that we were**

* in the starting period of a relationship and was not looking for a sexual relationship before knowing each other further. Sex without my consent or knowledge of sexual targeting.

UNUSUAL COMMENT:

George Georgio had made the comment : "Mistress"

I did not question this comment but had found it questionable and odd. I did not understand what he had meant by this comment.

On the Sunday, late morning I drove George Georgio back to Adelaide to go to the Adelaide Airport to for his flight back to Melbourne. We stopped at a Pizza Café within the metropolitan area CBD of Adelaide / corner café on an intersection, traffic lights on the left hand side heading towards the city / sidewalk dining available. George Georgio had spoken to the woman he shared the apartment with during our meal and had spoken affectionately towards her, affectionate words ; Darling / sweetheart
I found this odd and stared at him as if unimpressed which made him nervous in my company.

I then proceeded to drive George Georgio to the Adelaide Airport and dropped him off at the drive way to the entrance of the airport.

George Georgio had stated : "I'll be back sooner than you think"

I said goodbye to George Georgio and drove back to Port Pirie.

George Georgio had left the airline flight book in my possession when he left at my place of residence, [REDACTED] dated August 2014 - matches phone records of contact

That following week I had stated that I had found his interaction with the woman he lives with to be odd, suspicious and that his treatment towards me while we were together to be disrespectful and not good grounds in order to start a relationship.

True reason: Sex without my consent whilst I slept - Rape/ sexual abuse under the act of sexual targeting

I ceased all contact with George Georgio
