A similar \$50-million suit was filed in March 2008, by a different woman, who was represented by the same lawyer.^[129] These and several similar lawsuits were dismissed.^[130]

All other lawsuits have been settled by Epstein out of court.^[131] Epstein made many out-of-court settlements with alleged victims.^[130]

EPSTEIN - MAXWELL - SEXUAL ABUSE RING

Victims' rights: Jane Does v. United States (2014)

SEXUAL ABUSE RING

A December 30, 2014, federal civil suit was filed in Florida by Jane Doe 1 [REDACTED] and Jane Doe 2 against the United States for violations of the Crime Victims' Rights Act by the U.S. Department of Justice's NPA with Epstein and his limited 2008 state plea. There was a later unsuccessful effort to add [REDACTED] (Jane Doe 3) and another woman (Jane Doe 4) as plaintiffs to that case.^[132] The addition accused Alan Dershowitz of sexually abusing a minor, Jane Doe 3, provided by Epstein.^[133] The allegations against Dershowitz were stricken by the judge and eliminated from the case because he said they were outside the intent of the suit to re-open the plea agreement.^{[134][135]} A document filed in court alleges that Epstein ran a "sexual abuse ring", and lent underage girls to "prominent American politicians, powerful business executives, foreign presidents, a well-known prime minister, and other world leaders".^[136]

This long-running lawsuit is pending in federal court, aimed at vacating the federal plea agreement on the grounds that it violated victims' rights.^[137] On April 7, 2015, Judge Kenneth Marra ruled that the allegations made by alleged victim [REDACTED] against Prince Andrew had no bearing on the lawsuit by alleged victims seeking to reopen Epstein's non-prosecution plea agreement with the federal government; the judge ordered that allegation to be struck from the record.^[134] Judge Marra made no ruling as to whether claims by [REDACTED] are true or false. Though he did not allow Jane Does 3 and 4 to join the suit, Marra specifically said that [REDACTED] may later give evidence when the case comes to court.^[138]

On February 21, 2019, in the case of *Two Jane Does v. United States*, Senior Judge of the U.S. District Court for the Southern District of Florida Kenneth Marra said federal prosecutors violated the law by failing to notify victims before they allowed him to plead guilty to only the two Florida offenses. The judge left open what the possible remedy could be.^[139]

[REDACTED] v. Epstein (2015)

In a December 2014 Florida court filing by Bradley Edwards and Paul G. Cassell meant for inclusion in the Crime Victims Rights Act lawsuit,^[140] [REDACTED] (then known as [REDACTED]) alleged in a sworn affidavit that at age 17, she had been sexually trafficked by Epstein and Ghislaine Maxwell for their own use and for use by several others, including Prince Andrew^[141] and retired Harvard Law professor Alan Dershowitz.^{[8][142]} [REDACTED] also claimed that Epstein, Maxwell and others had physically and sexually abused her.^[143] She alleged that the FBI may have been involved in a cover-up.^[144] She said she had served as Epstein's sex slave from 1999 to 2002, and had recruited other underage girls.^[145] Prince Andrew, Epstein, and Dershowitz all denied having had sex with [REDACTED]. Dershowitz took legal action over the allegations.^{[146][147][148]} [REDACTED] filed a defamation suit against Dershowitz,

discomfort.^[205] Gates said in 2011 about Epstein: "His lifestyle is very different and kind of intriguing although it would not work for me".^[206]

The depth of the friendship between Gates and Epstein is unclear. Gates generally commented about his relationship with Epstein that "I met him. I didn't have any business relationship or friendship with him".^[207] However, Gates visited Epstein "many times, despite [Epstein's] past".^[205] Gates took at least one flight in 2013 in Epstein's infamous *Lolita Express* aircraft.^[205]

It was reported that Epstein and Gates "discussed the Gates Foundation and philanthropy".^[205] However, in an interview in 2019 Gates completely denied any connection between Epstein and the Gates Foundation or his philanthropy generally.^[207] In August 2021, Gates said the reason he had meetings with Epstein was because Gates hoped Epstein could provide money for philanthropic work, though nothing came of the idea. Gates added, "It was a huge mistake to spend time with him, to give him the credibility of being there."^[85]

* It has also been reported that Epstein and Gates met with Nobel Committee chair Thorbjørn Jagland at his residence in Strasbourg, France in March 2013 to discuss the Nobel Prize.^{[208][209]} Also in attendance were representatives of the International Peace Institute which has received millions in grants from the Gates Foundation, including a \$2.5 million "community engagement" grant in October 2013.^[210]

Public image

Gates's public image has changed over the years. At first he was perceived as a brilliant but ruthless "robber baron", a "nerd-turned-tycoon".^[211] Starting in 2000 with the foundation of the Bill and Melinda Gates Foundation, and particularly after he stepped down as head of Microsoft, he turned his attention to philanthropy, spending more than \$50 billion on causes like health, poverty, and education. His image morphed "from tyrannical technocrat to saintly savior", a "huggable billionaire techno-philanthropist", celebrated on magazine covers and sought after for his opinions on major issues like global health and climate change.^[211] Still another shift in public opinion came in 2021 with the announcement that he and Melinda were divorcing. Coverage of that proceeding brought out information about romantic pursuits of women who worked for him, a long-term extra-marital affair, and a friendship with convicted child sex trafficker Jeffrey Epstein.^[206] This resulted in some deterioration of his public image.^[212]

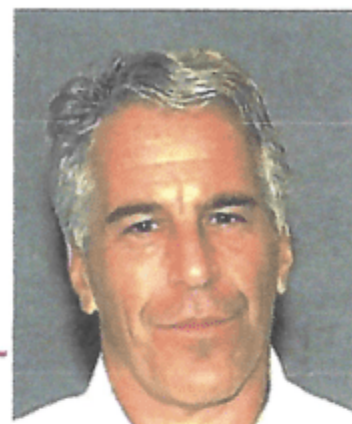
Religion

In an interview with *Rolling Stone*, Gates said in regard to his faith: "The moral systems of religion, I think, are super important. We've raised our kids in a religious way; they've gone to the Catholic church that Melinda goes to and I participate in. I've been very lucky, and therefore I owe it to try and reduce the inequity in the world. And that's kind of a religious belief. I mean, it's at least a moral belief."^[213] In the same 2014 interview he also said: "I agree with people like Richard Dawkins that mankind felt the need for creation myths. Before we really began to understand disease and the weather and things like that, we sought false explanations for them. Now science has filled in some of the realm – not all – that religion used to fill. But the mystery and the beauty of the world is overwhelmingly amazing, and there's no scientific explanation of how it came

Relationship with Jeffrey Epstein

Accounts differ on when Maxwell first met American financier Jeffrey Epstein. According to Epstein's former business partner, Steven Hoffenberg, Robert Maxwell introduced his daughter to Epstein in the late 1980s.^[49] *The Times* reported that Maxwell met Epstein in the early 1990s at a New York party following "a difficult break-up with Count Gianfranco Cicogna Mozzoni" (1962–2012) of the CIGA Hotels clan.^[50]

Maxwell had a romantic relationship with Epstein for several years in the early 1990s and remained closely associated with him for more than 25 years until his death in 2019.^{[22][48][51]} The nature of their relationship remains unclear. In a 2009 deposition, several of Epstein's household employees testified that Epstein referred to her as his "main girlfriend" who also hired, fired, and supervised his staff, starting around 1992.^[52] She has also been referred to as the "Lady of the House" by Epstein's staff and as his "aggressive assistant".^[53] In a 2003 *Vanity Fair* profile on Epstein, author Vicky Ward said Epstein referred to Maxwell as "my best friend".^[54] Ward also observed that Maxwell seemed "to organize much of his life".^[54]

Politico reported that Maxwell and Epstein had friendships with several prominent individuals in elite circles of politics, academia, business and law, including former Presidents Donald Trump and Bill Clinton, attorney Alan Dershowitz, and Prince Andrew, Duke of York.^[55]

Maxwell is known for her longstanding friendship^[56] with Prince Andrew, and for having escorted him to a "hookers and pimps" social function in New York.^[57] She introduced Epstein to Prince Andrew, and the three often socialised together.^[58] In 2000, Maxwell and Epstein attended a party thrown by Prince Andrew at the Queen's Sandringham House estate in Norfolk, England, reportedly for Maxwell's 39th birthday.^[59] In a November 2019 interview with the BBC, Prince Andrew confirmed that Maxwell and Epstein had attended an event at his invitation, but he denied that it was anything more than a "straightforward shooting weekend".^[60]

In 1995, Epstein renamed one of his companies the Ghislaine Corporation; based in Palm Beach, Florida, the company was dissolved in 1998.^[52] As a trained helicopter pilot, Maxwell also transported Epstein to his private Caribbean island.^{[61][6]}

In 2008, Epstein was convicted of soliciting a minor for prostitution and served 13 months of an 18-month jail sentence. Following Epstein's release, although Maxwell continued to attend prominent social functions, she and Epstein were no longer seen together publicly.^[9]

By late 2015, Maxwell had largely retreated from attending social functions.^{[9][62]}



Jeffrey Edward Epstein (/ˈɛpstiːn/ *EP-steen*^[2] January 20, 1953 – August 10, 2019) was an American financier and convicted sex offender.^{[3][4]} Epstein, who was born and raised in Brooklyn, New York City, began his professional life by teaching at the Dalton School in Manhattan, despite lacking a college degree. After his dismissal from the school, he entered the banking and finance sector, working at Bear Stearns in various roles; he eventually started his own firm. Epstein developed an elite social circle and procured many women and children; he and some of his associates then sexually abused them.^{[5][4][6][7]}

In 2005, police in Palm Beach, Florida, began investigating Epstein after a parent complained that he had sexually abused her 14-year-old daughter.^[8] Epstein pleaded guilty and was convicted in 2008 by a Florida state court of procuring a child for prostitution and of soliciting a prostitute.^{[5][9]} He served almost 13 months in custody, but with extensive work release. He was convicted of only these two crimes as part of a controversial plea deal; federal officials had identified 36 girls, some as young as 14 years old, whom Epstein had allegedly sexually abused.^{[1][10]}

Epstein was arrested again on July 6, 2019, on federal charges for the sex trafficking of minors in Florida and New York.^{[11][12]} He died in his jail cell on August 10, 2019.^[13] The medical examiner ruled the death a suicide.^[14] Epstein's lawyers have disputed the ruling, and there has been significant public skepticism about the true cause of his death, resulting in numerous conspiracy theories.^{[15][16]} Since Epstein's death precluded the possibility of pursuing criminal charges against him, a judge dismissed all criminal charges on August 29, 2019.^{[17][18]} Epstein had a decades-long association with the British socialite Ghislaine Maxwell, leading to her 2021 conviction on U.S. federal charges of sex trafficking and conspiracy for helping him procure girls, including a 14-year-old, for child sexual abuse and prostitution.^{[19][20][21][22]} Epstein also maintained long-term relationships with various high-profile individuals, including Donald Trump, Leslie Wexner, Bill Clinton, Alan Dershowitz, and Prince Andrew, Duke of York.^[23]

Criminal charges

Arrest and indictment

Maxwell faced persistent allegations of procuring and sexually trafficking underage girls for Epstein and others, charges she denied.^[9] Maxwell was arrested in Bradford, New Hampshire by the FBI on 2 July 2020, through the use of an IMSI-catcher ("stingray") mobile phone tracking device on a phone used by her to call one of her lawyers, her husband Scott Borgerson, and her sister Isabel.^[103]

Maxwell was charged with enticement of minors, sex trafficking of children, and perjury.^{[10][104][105]} Prosecutors, led by United States District Attorney Audrey Strauss, charged her with six federal crimes, including enticement of minors, sex trafficking, and perjury.^{[104][106][107][108]} The indictment charged that between 1994 and 1997, she "assisted, facilitated, and contributed" to the abuse of minor girls despite knowing that one of three unnamed victims was 14 years old.^[109]

As of 28 April 2021, Maxwell was held at the Metropolitan Detention Center, Brooklyn, New York.^{[110][111][112]} Lawyers requested that Judge Nathan release her on \$5 million bond with monitored home confinement while awaiting trial.^[113] Maxwell appeared by video link before a court in Manhattan on 14 July 2020 and pleaded not guilty to the charges.^[114] A naturalised US citizen since 2002 who also holds passports from France and the United Kingdom, Maxwell was denied bail as a flight risk amid concerns regarding her "completely opaque" finances, her skill at living in hiding, and the fact that France does not extradite its citizens.^{[11][113][115][116][117]} The judge set a trial date of 12 July 2021.^{[114][118][119]}

Maxwell's attorney reiterated her request for bail on 18 December 2020, and proposed that Maxwell reside with a friend in New York City while under 24-hour surveillance as she awaited trial.^[120] Her husband, Scott Borgerson, made a secured offer of US\$22 million to guarantee her presence at future appearances.^[120] On 28 December 2020, a further request for bail was again rejected by the judge.^[121] Maxwell's bail request was opposed by alleged victim ██████████

On 19 January 2021, a court hearing was disrupted by believers in QAnon – who believe Maxwell to be working in cohort with a cabal of child-sacrificing Satanist liberal elites who traffic children for sex – as the proceedings were illegally livestreamed to YouTube.^{[122][123]}

On 26 January 2021, a motion by Maxwell's attorneys challenged her grand jury indictment, claiming that it did not reflect the ethnic diversity of the jurisdiction in which the violations of the law were alleged to have occurred.^[124]

On 29 March 2021, US prosecutors added new charges of sex trafficking a minor and sex trafficking conspiracy, alleging that Maxwell was involved in grooming a fourth girl, aged 14, to engage in sexual acts with Epstein between 2001 and 2004 at his Palm Beach estate.^{[125][126]} Maxwell pleaded not guilty to the additional charges; she faced six counts that included sex trafficking of a minor and sex trafficking conspiracy, in addition to two counts of perjury.^[127]

Maxwell's attorneys regularly protested about the conditions of her confinement, which included being kept awake by a light shone in her eyes every fifteen minutes to deter the chances of her committing suicide, and being denied a sleep mask.^[128] One, David Marcus, protested, "There's no

which he purchased from his mentor.^[61] Before the Herbert Straus house was purchased, Wexner purchased in 1988 the adjacent townhouse at 11 East 71st Street. Like in the case of the 9 East 71st Street house, Epstein was on the deed of the 11 East 71st Street house as the trustee. The townhouse was sold in 1996 to the Comet trust which holds part of the assets of the de Gunzburg/Bronfman family.^[270]

Epstein rented offices for his business dealings in the Villard House at 457 Madison Avenue.^[92] Steven Hoffenberg originally set up the offices for Epstein in 1987 when he was consulting for Tower Financial.^[30] Epstein used these offices until at least 2003. Around this time, Michael Wolff saw the financier in his office, which in the past were the offices of Random House.^[92] Wolff noted that Epstein's offices were a strange place which did not have a corporate feel at all. Wolff stated that the offices were "almost European. It's old—old-fashioned, unrehabbed in its way." Wolff continued that "the trading floor is filled with guys in yarmulkes. Who they are, I have no idea. They're like a throwback, a bunch of guys from the fifties. So here is Jeffrey in this incredibly beautiful office, with pieces of art and a view of the courtyard, and he seems like the most relaxed guy in the world. You want to say 'What's going on here?' and he gives you that Cheshire smile."^[92]

Epstein rented multiple apartment units for his employees, models, and guests since the 1990s at 301 East 66th Street. The majority of the apartment complex at this address is owned by Ossa properties, which is owned by Jeffrey Epstein's brother, Mark, who purchased the complex in the early 1990s from Wexner. Over the years Epstein has housed different friends at 11 East 71st Street, including his ex-girlfriend Eva Andersson, who is now married to his hedge-fund friend Glenn Dubin, MC2 Models founder Jean-Luc Brunel, and on occasions former Israeli Prime Minister Ehud Barak. He has housed some of his workers, including his pilot, housekeeper and office work staff, in the apartment complex. Epstein has also housed underage girls, who Brunel scouted for his MC2 modeling agency.^{[80][81]} On August 6, 2012, a model and party promoter associated with MC2, Pedro Gaspar, who lived above another of the modeling agency's locations in Manhattan, died of what some consider to be a suspicious drug overdose.^[271]

Political donations

From 1989 until 2003, Epstein donated more than \$139,000 to U.S. Democratic Party federal candidates and committees and over \$18,000 to U.S. Republican Party candidates and groups.^[272]

Epstein contributed \$50,000 to Democrat Bill Richardson's successful campaign for Governor of New Mexico in 2002 and again for his successful run for reelection in 2006. Also that year, he contributed \$15,000 to Democrat Gary King's successful campaign for Attorney General of New Mexico. He later contributed \$35,000 to King's 2014 unsuccessful campaign for Governor. Other contributions in New Mexico included Epstein \$10,000 toward Jim Baca's campaign to become head of the land commission and \$2,000 toward Santa Fe County Sheriff Jim Solano's bid for reelection. In 2010, Epstein received a notice from New Mexico Department of Public Safety which said, "You are not required to register [as a sex offender] with the state of New Mexico." This was in contravention of federal law, which would seem to say that the conviction in Florida required him to register in New Mexico.^[273]

Philanthropy

In 1991, Epstein was one of four donors who pledged to raise US\$2 million for a Hillel student building Rosovsky Hall at Harvard University.^{[274][275]} In 2000, Epstein established the Jeffrey Epstein VI Foundation, which funds science research and education. Prior to 2003, the foundation funded Martin Nowak's research at the Institute for Advanced Study in Princeton, New Jersey. In May 2003, Epstein pledged a series of donations totaling US\$30 million to create a mathematical

biology and evolutionary dynamics program at Harvard which was run by Martin Nowak.^[274] According to *The Boston Globe*, the actual amount received from Epstein was US\$6.5 million.^{[125][274][275]} In 2019, *Forbes* deleted a 2013 article that called Epstein "one of the largest backers of cutting edge science" after *The New York Times* revealed its author, Drew Hendricks, had been paid \$600 to submit it falsely as his own.^[205]

According to attorney Gerald B. Lefcourt, Epstein was "part of the original group that conceived of the Clinton Global Initiative".^[276] Epstein co-organized a science event with illusionist and skeptic Al Seckel called the Mindshift Conference.^[277] The conference took place in 2010 on Epstein's private island Little Saint James.^[277] In attendance were scientists Murray Gell-Mann, Leonard Mlodinow, and Gerald Jay Sussman.^[41]

The true extent of Epstein's donations is unknown. The Jeffrey Epstein VI Foundation fails to disclose information which other charities routinely disclose. Concerns have been raised over this lack of transparency. In 2015, the Attorney General of the state of New York was reported to be trying to gain information but was refused since the charities were based outside of the state and did not solicit in New York State.^[278] Epstein, besides making donations through the Jeffrey Epstein VI Foundation, also made a number of charitable donations through his three private charities: Epstein Interest, the COUQ Foundation, and Gratitude American Ltd. According to federal tax filings, Epstein donated \$30 million between 1998 and 2018, through these three charities.^[279] Following his death, a number of scientists and institutions—including Harvard University and Massachusetts Institute of Technology (MIT)—came under criticism for accepting money from Epstein and his foundation, with some individuals offering to give away money donated by Epstein.^[280]

Interest in eugenics and transhumanism

According to various sources, beginning in the early 2000s Epstein developed a strong interest in improving the human race through genetic engineering and artificial intelligence, including using his own sperm. He addressed the scientific community at various events and occasions and communicated his fascination with eugenics.^[281] It was reported in August 2019 that Epstein had planned to "seed the human race with his DNA" by impregnating up to 20 women at a time using his New Mexico compound as a "baby ranch", where mothers would give birth to his offspring. He was an advocate of cryonics and his own idiosyncratic version of transhumanism, and had said that he intended to have his penis and head frozen.^{[282][283]}

Kathleen Hall Jamieson, director of the Annenberg Public Policy Center at the University of Pennsylvania said: "Scientists need funding for important work ... if the funding is for legitimate scientific work, there is nothing wrong with accepting support from a billionaire. However it would have been wrong for scientists to accept his funding if they were aware that he was planning a eugenics experiment that might draw legitimacy from his association with them." Professor George Church also publicly apologized for meeting Epstein after his 13-month sentence, saying "There should have been more conversations about, should we be doing this, should we be helping this guy? There was just a lot of nerd tunnel vision."^[280]

Death

claiming he purposefully made "false and malicious defamatory statements" about her.^[111] A diary purported to belong to ██████ was published online.^{[149][150]} Epstein entered an out-of-court settlement with Giuffre, as he had done in several other lawsuits.^[89]

In 2019, ██████ was interviewed by the BBC's *Panorama* where she continued to attest that Epstein had trafficked her to Prince Andrew.^[151] She appealed directly to the public by stating "I implore the people in the UK to stand up beside me, to help me fight this fight, to not accept this as being ok."^[151] As of 2016, these accusations had not been tested in any court of law.^[152]

██████ v. Ghislaine Maxwell (2015)

As a result of ██████ allegations and Maxwell's comments about them, ██████ sued Maxwell for defamation in September 2015. After much legal confrontation, the case was settled under seal in May 2017. The *Miami Herald*, other media, and Alan Dershowitz filed to have the documents about the settlement unsealed. After the judge dismissed their request, the matter was appealed to the U.S. Court of Appeals for the Second Circuit.^[153]

On March 11, 2019, in the appeal of the district judge's refusal to unseal the documents relating to the 2017 defamation settlement of ██████ v. *Maxwell*, the Second Circuit Court gave parties one week to provide good cause as to why they should remain under seal, without which they would be unsealed on March 19, 2019. Later the Court ordered these documents to be unsealed (after having them redacted to protect innocent parties). In ██████ testimony, she claims that she was "directed" by Maxwell to give erotic massages and engage in sexual activities with Prince Andrew; Jean-Luc Brunel; Glenn Dubin; Marvin Minsky; Governor Bill Richardson; another unnamed prince; an unnamed foreign president; "a well known Prime Minister"; and an unnamed hotel chain owner from France, among others.^[154] The deposition does not claim that any of these men in fact engaged with ██████, and as of August 2019, none of these men have been indicted or sued for related sex crimes.^[154] ██████ testified, "my whole life revolved around just pleasing these men and keeping Ghislaine and Jeffrey happy. Their whole entire lives revolved around sex."^{[154][153]}

On August 9, less than 24 hours before Epstein's death, 2,000 pages of previously sealed documents from the case were released. Two sets of additional sealed documents will be analyzed by a federal judge to determine whether they should also be made public. A "John Doe" asked the judge on September 3 to permanently keep the documents secret, claiming "unproven allegations of impropriety" could damage his reputation, though he had no evidence his name was included.^[155]

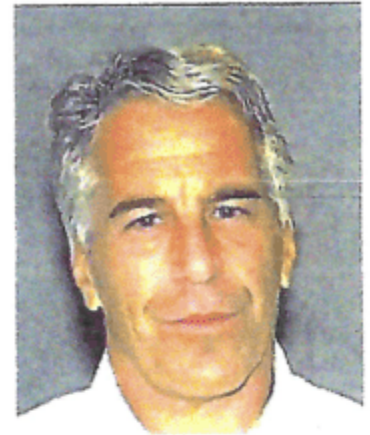
Jane Doe v. Epstein and Trump (2016)

A federal lawsuit filed in California in April 2016, against Epstein and Donald Trump by a California woman alleged that the two men sexually assaulted her at a series of parties at Epstein's Manhattan residence in 1994, when she was 13 years old. The suit was dismissed by a federal judge in May 2016 because it did not raise valid claims under federal law. The woman filed another federal suit in New York in June 2016, but it was withdrawn three months later, apparently without being served on the defendants. A third federal suit was filed in New York in September 2016.

The two latter suits included affidavits by an anonymous witness who attested to the accusations in the suits, asserting Epstein employed her to procure underage girls for him, and an anonymous person who declared the plaintiff had told him/her about the assaults at the time they occurred. The plaintiff, who had filed anonymously as Jane Doe, was scheduled to appear in a Los Angeles press conference six days before the 2016 election, but abruptly canceled the event; her lawyer Lisa

In March 2005, a woman contacted Florida's Palm Beach Police Department and alleged that her 14-year-old stepdaughter had been taken to Epstein's mansion by an older girl. While there, she was allegedly paid \$300 (equivalent to \$420 in 2021) to strip and massage Epstein.^[92] She had allegedly undressed, but left the encounter wearing her underwear.^[93]

Palm Beach Police began a 13-month undercover investigation of Epstein, including a search of his home.^{[71][94]} During the investigation, Palm Beach Police Chief Michael Reiter publicly accused the Palm Beach County state prosecutor, Barry Krischer, of being too lenient and called for help from the FBI.^[92]

The Federal Bureau of Investigation (FBI) then became involved. Subsequently, the police alleged that Epstein had paid several girls to perform sexual acts with him.^[89] Interviews with five alleged victims and 17 witnesses under oath, a high-school transcript and other items found in Epstein's trash and home allegedly showed that some of the girls involved were under 18, the youngest being 14, with many under 16.^{[95][96]} The police search of Epstein's home found two hidden cameras and large numbers of photos of girls throughout the house, some of whom the police had interviewed in the course of their investigation.^[93] [REDACTED], a former model from Poland who became an Epstein assistant, reportedly removed computer drives and other electronic equipment from the financier's Florida mansion before Palm Beach Police searched the home as part of their investigation.^[97] The court documents record that a search of Epstein's residence by Palm Beach Police detective Joseph Reçarey in 2005 uncovered an incriminating Amazon receipt containing books on S&M. The books he ordered are titled: *SM 101: A Realistic Introduction*, *SlaveCraft: Roadmaps for Erotic Servitude – Principles, Skills and Tools* and *Training with Miss Abernathy: A Workbook for Erotic Slaves and Their Owners.*^[98]

EPSTEIN - VINCENT BULLONE - FRANCE - SEXUAL ABUSE MINOR

A former employee told the police that Epstein would receive massages three times a day.^[93] Eventually the FBI compiled reports on "34 confirmed minors" eligible for restitution (increased to 40 in the NPA) whose allegations of sexual abuse by Epstein included corroborating details.^[99] Julie Brown's 2018 exposés in the *Miami Herald* identified about 80 victims and located about 60 of them.^{[1][71][100]} She quotes the then police chief Reiter as saying "This was 50-something 'shes' and one 'he'—and the 'shes' all basically told the same story."^[1] Details from the investigation included allegations* that 12-year-old triplets were flown in from France for Epstein's birthday, and flown back the following day after being sexually abused by the financier. It was alleged that young girls were recruited from Brazil and other South American countries, former Soviet countries, and Europe, and that Jean-Luc Brunel's "MC2" modeling agency was also supplying girls to Epstein.^{[95][101][102]}

In May 2006, Palm Beach police filed a probable cause affidavit saying that Epstein should be charged with four counts of unlawful sex with minors and one count of sexual abuse.^{[93][103]} On July 27, 2006, Epstein was arrested by the Palm Beach Police Department on state felony charges of procuring a minor for prostitution and solicitation of a prostitute. He was booked at the Palm Beach County jail and later released on a \$3,000 bond.^{[5][9][104][105]} State prosecutor Krischer later convened a Palm Beach County grand jury, which was usually only done in capital cases. Presented evidence from only two victims, the grand jury returned a single charge of felony solicitation of prostitution,^[106] to which Epstein pleaded not guilty in August 2006.^[107]

Epstein's defense lawyers included Roy Black, Gerald Lefcourt, Harvard Law School professor Alan Dershowitz, and former U.S. Solicitor General Ken Starr.^{[92][108]} Linguist Steven Pinker also assisted.^[109]

residence as Saudi Arabia.^{[50][51][191][192][193]} According to his attorneys, Epstein had been advised to acquire the passport because "as an affluent member of the Jewish faith", he was in danger of being kidnapped while traveling abroad.^[194]

On July 8, prosecutors with the Public Corruption Unit of the Southern District of New York charged him with sex trafficking and conspiracy to traffic minors for sex. The grand jury indictment alleges that "dozens" of underage girls were brought into Epstein's mansions for sexual encounters.^{[11][12][195]} Judge Kenneth Marra was to decide whether the non-prosecution agreement that protected Epstein from the more serious charges should still stand.^[196]

Epstein requested to be released on bond, offering to post \$100 million with the condition that he would also submit to house arrest in his New York City mansion.^[197] U.S. District Judge Richard M. Berman denied the request on July 18, saying that Epstein posed a danger to the public and a serious flight risk to avoid prosecution.^[197]

On July 23, Epstein was found injured and semiconscious at 1:30 a.m. on the floor of his cell, with marks around his neck that were suspected to be the result of either a suicide attempt or an assault.^[198] His cellmate, former New York City police officer Nicholas Tartaglione, who was charged with four counts of murder, was questioned about Epstein's condition. He denied having any knowledge of what happened. Epstein himself said he recollected nothing.^{[190][199][200][201]} According to NBC News, two sources said that Epstein might have tried to hang himself, a third said the injuries were not serious and could have been staged, and a fourth source said that an assault by his cellmate had not been ruled out.^[202]

On August 29, 2019, following Epstein's death 10 days prior, the case against Epstein was closed after Judge Berman dismissed all sex trafficking charges.^{[17][18]} However, he also expressed support for Epstein's accusers.^[17] Prosecutors objected to the ruling and stated they would continue an investigation for potential co-conspirators.^[18]

Investigation in France - VINCENT BULONE - SEXUAL TARGETING 2018 - 2019

On August 23, 2019, the prosecutor's office in Paris, France, opened a preliminary investigation into Epstein. He is being investigated for rape and sexual assault of minors under and over the age of 15, criminal association with a view to committing crimes, and association with criminals with a view to committing offenses. The prosecutors said that the goal of the investigation is to find possible crimes committed in France and elsewhere against French citizens.^[203]

Personal life

Previous long-term girlfriends associated with Epstein include Eva Andersson-Dubin^{[204][205]} and publishing heiress Ghislaine Maxwell.^[30] Epstein was romantically linked to Andersson-Dubin for an 11-year period^[206] mostly in the 1980s and the two later remained friendly well after her marriage to Glenn Dubin.^{[204][205]} Epstein met Maxwell, daughter of disgraced media baron Robert Maxwell, by 1991.^{[162][207][208]} Epstein had Maxwell come to the United States in 1991 to recover from her grief following the death of her father.^[209] Maxwell was implicated by several of Epstein's accusers as procuring or recruiting underage girls in addition to once being Epstein's girlfriend.^{[161][162][208]} In a 2009 deposition, several of Epstein's household employees testified that Maxwell had a central role in both his public and private life, referring to her as his "main

Bloom asserted that the woman had received threats. The suit was dropped on November 4, 2016. Trump attorney Alan Garten denied the allegations, while Epstein declined to comment.^{[156][157][158][159][160]}

██████████ v. Epstein and Maxwell (2017)

In 2017, ██████████ filed a suit against Epstein and Maxwell, alleging that Maxwell had hired her to give massages to Epstein and later threatened to physically harm her or destroy her career prospects if she did not comply with their sexual demands at his mansion in New York City and on his private Caribbean island, Little Saint James. The suit was settled in 2018 under undisclosed terms.^{[161][20][162]}



Epstein was accused of sex trafficking of minors at his mansion at 9 East 71st Street.

Bradley Edwards' defamation v. Epstein (2018)

A state civil lawsuit in Florida filed by attorney Bradley Edwards against Epstein was scheduled for trial in December 2018. The trial was expected to provide victims with their first opportunity to make their accusations in public. However, the case was settled on the first day of the trial, with Epstein publicly apologizing to Edwards; other terms of the settlement were confidential.^{[137][163]}

██████████ v. Epstein and Maxwell (2019)

On April 16, 2019, ██████████ went public and filed a sworn affidavit in federal court in New York, alleging that she and her 15-year-old sister, Annie, had been sexually assaulted by Epstein and Maxwell in separate locations in 1996. ██████████ met Epstein and Maxwell at her graduate art gallery reception at the New York Academy of Art in 1995. The following year, in the summer of 1996, they hired her to work on an art project in Leslie Wexner's Ohio mansion, where she was then sexually assaulted.^[164] ██████████ reported the incident to the New York City Police Department and the FBI.^[165]

██████████'s affidavit also stated that during the same summer, Epstein flew her then-15-year-old sister to his New Mexico property where he and Maxwell sexually abused her on a massage table.^[166]

GRADUALLY GROOMED - MAXWELL

██████████ v. Epstein and Maxwell (2019)

On July 22, 2019, while in jail awaiting trial, Epstein was served with a petition regarding a pending state civil lawsuit filed by ██████████^[167] She stated that an associate for Epstein had recruited her outside Talent Unlimited High School at age 14 and she was gradually groomed over a year before Epstein raped her in his New York City mansion when she was 15.^[168] Araoz filed her suit on August 14, 2019, when New York State law was updated to allow one year for adult survivors of child sexual abuse to sue for previous offenses, regardless of how long ago the abuse took place.^[169] In October 2019, Araoz amended her complaint to include over 20 corporate entities associated with Epstein and named the additional individuals Lesley Groff and ██████████ as enablers.^[170]

Katlyn Doe, et al. v. Epstein's estate (2019)

Non-prosecution agreement (NPA) (2006–2008)

In July 2006, the FBI began its own investigation of Epstein, nicknamed "Operation Leap Year".^[110] It resulted in a 53-page indictment in June 2007.^[71] Alexander Acosta, then the U.S. Attorney for the Southern District of Florida, agreed to a plea deal, which Alan Dershowitz helped to negotiate,^[111] to grant immunity from all federal criminal charges to Epstein, along with four named co-conspirators and any unnamed "potential co-conspirators".^{*} According to the *Miami Herald*, the non-prosecution agreement "essentially shut down an ongoing FBI probe into whether there were more victims and other powerful people who took part in Epstein's sex crimes". At the time, this halted the investigation and sealed the indictment. The *Miami Herald* said: "Acosta agreed, despite a federal law to the contrary, that the deal would be kept from the victims."^[1]

The controversial non-prosecution agreement

Acosta later said he offered a lenient plea deal because he was told that Epstein "belonged to intelligence", was "above his pay grade" and to "leave it alone".^{[52][53][112]} Epstein agreed to plead guilty in Florida state court to two felony prostitution charges, serve 18 months in prison, register as a sex offender, and pay restitution to three dozen victims identified by the FBI.^{[1][89]} The plea deal was later described as a "sweetheart deal".^[113]

A federal judge later found that the prosecutors had violated the victims' rights in that they had concealed the agreement from the victims and instead urged them to have "patience".^{[114][115]}

According to an internal review conducted by the Department of Justice's Office of Professional Responsibility, which was released in November 2020, Acosta showed "poor judgment" in granting Epstein a non-prosecution agreement and failing to notify Epstein's alleged victims about this agreement.^[116]

Conviction and sentencing (2008–2011)

On June 30, 2008, after Epstein pleaded guilty to a state charge (one of two) of procuring for prostitution a girl below age 18,^[117] he was sentenced to 18 months in prison. While most convicted sex offenders in Florida are sent to state prison, Epstein was instead housed in a private wing of the Palm Beach County Stockade and, according to the sheriff's office, was after 3½ months allowed to leave the jail on "work release" for up to 12 hours a day, 6 days a week. This contravened the sheriff's own policies requiring a maximum remaining sentence of 10 months and making sex offenders ineligible for the privilege. He was allowed to come and go outside of specified release hours.^[100]

Epstein's cell door was left unlocked, and he had access to the attorney room where a television was installed for him, before he was moved to the Stockade's previously unstaffed infirmary. He worked at the office of a foundation he had created shortly before reporting to jail; he dissolved it after he had served his time. The Sheriff's Office received \$128,000 from Epstein's non-profit to pay for the costs of extra services being provided during his work release. His office was monitored by "permit deputies" whose overtime was paid by Epstein. They were required to wear suits, and checked in "welcomed guests" at the "front desk". Later the Sheriff's Office said these guest logs were destroyed per the department's "records retention" rules (although inexplicably the Stockade visitor logs were not).^[118] He was allowed to use his own driver to drive him between jail and his office and other appointments.^{[100][118]}

John Winston Howard OM AC (born 26 July 1939) is an Australian former politician who served as the 25th prime minister of Australia from 1996 to 2007, holding office as leader of the Liberal Party of Australia. His eleven-year tenure as prime minister is the second-longest in history, behind only Sir Robert Menzies, who served for eighteen non-consecutive years. He has also been the oldest living former Australian prime minister since the death of Bob Hawke in 2019.

Howard was born in Sydney and studied law at the University of Sydney. He was a commercial lawyer before entering parliament. A former federal president of the Young Liberals, he first stood for office at the 1968 New South Wales state election, but lost narrowly. At the 1974 federal election, Howard was elected as a member of parliament (MP) for the division of Bennelong. He was promoted to cabinet in 1977, and later in the year replaced Phillip Lynch as treasurer of Australia, remaining in that position until the defeat of Malcolm Fraser's government at the 1983 election.

In 1985, Howard was elected leader of the Liberal Party for the first time, thus replacing Andrew Peacock as Leader of the Opposition. He led the Liberal-National coalition to the 1987 federal election, but lost to Bob Hawke's Labor government, and was removed from the leadership in 1989. Remaining a key figure in the party, Howard was re-elected leader in 1995 (replacing Alexander Downer), and subsequently led the Coalition to a landslide victory at the 1996 federal election.

After defeating Paul Keating's Labor government in 1996, the Howard Government was re-elected at the 1998, 2001 and 2004 elections. Howard's actions as prime minister included implementing new gun laws in response to the Port Arthur massacre, the introduction of a nationwide value-added tax, immigration reform, and a controversial set of industrial relations reforms. Under his governance, Australia also contributed troops to the War in Afghanistan and the Iraq War, and led the International Force for East Timor. The Howard government was defeated at the 2007 federal election, with the Labor Party's Kevin Rudd succeeding him as prime minister. Howard also lost his own seat of Bennelong at the election to Maxine McKew, becoming only the second prime minister to do so, after Stanley Bruce in 1929. Following this loss, Howard retired from politics.

Bishop joined the Liberal Party in 1992. She has credited the WA Inc scandal with making her think she "did not ever want to see a Labor government elected again".^[12] She was chosen as the president of the Liberal party's CBD branch the year she joined the party, serving until 1997.^[8] In 1998, Senator Nick Minchin invited her to serve as an appointed delegate to the 1998 national constitutional convention. She was a "minimalist republican", and voted against the final model because she considered it too radical and unlikely to succeed at a referendum. At the convention, she became acquainted with Peter Costello, at the time serving as federal treasurer under John Howard.^[17]

Howard Government

First years in parliament

Prior to the 1998 federal election, Bishop won Liberal preselection for the Division of Curtin, which takes in Perth's western suburbs. Her preselection bid received the support of Premier Richard Court, who had earmarked her as a future member of federal cabinet.^[12] The seat had been held for 17 years by Allan Rocher, who was a personal friend of Prime Minister John Howard but had left the Liberals in 1995 to sit as an independent. Howard did not want the Liberals to run a candidate against Rocher, and refused to campaign for Bishop; however, Peter Costello and Alexander Downer both supported her candidacy and Costello launched her campaign.^[17] At the election, she reclaimed the seat for the Liberals with a large swing in her favour.^[6]

After the Liberal Party lost the 2001 state election in Western Australia, Bishop was suggested by multiple media sources as a possible replacement for Richard Court as state Liberal leader (and thus Leader of the Opposition).^[17] It was later confirmed that Court favoured an arrangement where he and his deputy and factional rival, Colin Barnett, would resign their seats in the Legislative Assembly. Bishop would resign from federal Parliament and hand her seat to Barnett, and Court would hand the leadership of the WA Liberals to Bishop once she was safely in the state legislature by way of winning either Court or Barnett's old seats, both of which were within Curtin's boundaries and were comfortably safe for the Liberals.^{[18][19]} However, Bishop eventually rejected the deal.^[17]

Elevation to the ministry - MINISTER OF EDUCATION & SCIENCE

Bishop was appointed Minister for Ageing by Prime Minister John Howard in 2003. She was later promoted to Minister for Education and Science and Minister for Women in 2006 and served in those positions until the defeat of the Howard Government at the 2007 federal election.

As education minister, Bishop's policies centred on the development of national education standards as well as performance-based pay for teachers.^[20] On 13 April 2007, the Australian State Governments jointly expressed opposition to Bishop's pay policy. In the 2007 budget, the Federal Government announced a \$5 billion "endowment fund" for higher education, with the expressed goal of providing world-class tertiary institutions in Australia.^[21] Some of Bishop's public comments on education, including the remark that "the states have ideologically hijacked school syllabi and are wasting \$180 million in unnecessary

Four hours after the close of polls, at approximately 10pm ACDST, incumbent Premier Jay Weatherill telephoned Steven Marshall and conceded defeat. Weatherill subsequently publicly announced that he had conceded, saying, "I'm sorry I couldn't bring home another victory, but I do feel like one of those horses that has won four Melbourne Cups and I think the handicap has caught up with us on this occasion."^{[77][78][79][80]}

Peter Malinauskas became Leader of the Opposition and succeeded Weatherill who had resigned as Labor leader, with Susan Close as deputy, following a Labor caucus meeting on 9 April 2018.^[81]

In July 2019, he was appointed to conduct a review of Federal Labor's loss at the 2019 Australian federal election.^[83] In 2021, he was reported to have moved to Perth, Western Australia and be working for Andrew Forrest's Minderoo Foundation, promoting an early childhood development campaign named *Thrive by Five*.^[84]

In the 2021 Australia Day Honours, Weatherill was awarded Officer of the Order of Australia for "distinguished service to the people and Parliament of South Australia, particularly as Premier, and to early childhood and tertiary education".^[85]

Weatherill is married to Melissa, and they have two young daughters.^[86] He is a supporter of the Port Adelaide Football Club.^[87]

fell.^[32] Despite this, the government included funding for the Gawler railway line up to Dry Creek, a number of measures supporting small businesses and entrepreneurs, and promised a return to surplus by 2015–2016.^[33]

During the 2013 Federal Election, both Liberal and Labor promised that the next round of the country's submarines (12) would be built in South Australia, however after the election it appeared that the Liberal Government had arranged to buy just eight submarines directly from Japan.^[34] Following an organised campaign by Jay Weatherill and Labor, the Advertiser newspaper, workers at the Australian Submarine Corporation and the South Australian public, a "competitive evaluation process" was announced by the Federal Government, with the final contract for a South Australian build awarded to French company DCNS with majority of the work to take place in Osborne, South Australia.^[35] Following the announcement, Jay Weatherill travelled to France to meet with DCNS and others in an attempt to maximise opportunities for South Australia.^[36]

Weatherill also released the French Engagement Strategy, a plan to strengthen economic and business ties with France, also focusing on broader opportunities in areas such as education, tourism and the arts.^[37]

In December 2013 Holden announced it would withdraw production from Australia. At the time Holden directly employed 1,600 people in its Elizabeth plant in South Australia, with a total of 3,000 job losses predicted through the supply chain.^[38] While Liberal Shadow Treasurer Rob Lucas claimed South Australia was "careering toward double digit unemployment" after the closure,^[39] strong support from the Weatherill Labor Government ensured the small business sector grew above trend after the closure^[40] with unemployment at 6% in January 2017, three months after.^[41]

The 2014 State election resulted in a hung parliament with 23 seats for Labor, 22 for the Liberals, and the balance of power resting with the two independents, Bob Such and Geoff Brock. After Such went on medical leave for a brain tumour without indicating his support, political commentators indicated that Brock would likely back Labor by reason of 'political stability'.^[42] Brock did back Labor, giving Labor 24 seats and as a result Weatherill formed a minority government - giving Labor a total four terms in government.^[43]

Second term

Weatherill joined with Liberal premiers proclaiming he would lead a national campaign against the then federal Abbott Government's 2014 federal budget.^[44] Former Liberal Leader Martin Hamilton-Smith then defected, becoming an independent and entered the Weatherill cabinet. Hieu Van Le was announced on 26 June 2014 as the next Governor of South Australia to replace Kevin Scarce.^[45] Following the death of Such, Labor won the 2014 Fisher by-election by nine votes from a 7.3 percent two-party swing in a hotly contested three-cornered contest. Weatherill nonetheless kept Brock and Hamilton-Smith in cabinet, giving the government a 26 to 21 parliamentary majority.^[46]

In 2015, Weatherill initiated the Nuclear Fuel Cycle Royal Commission to investigate opportunities and risks associated with expanding the state's involvement in the nuclear fuel cycle. The Commission was headed by former Governor Kevin Scarce and delivered its final report and

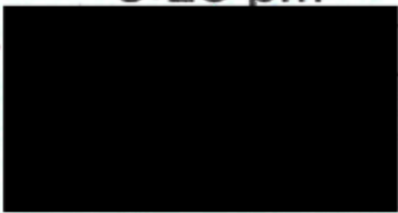

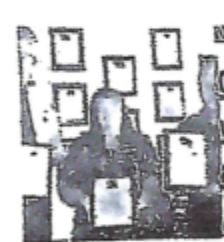

I met Vincent Bulone on AMM Dating Site (Adult Match Maker). I did not pay for an account with this dating site and could not contact anyone (send first message) only answer messages that I was sent. I received first contact from Vincent Bulone, his profile displaying woman's photographs and stating that he was in a relationship and looking for sexual exploration in sexual conduct of threesomes.

I was contacted by the woman in the photographs (portrayed as a woman) Vincent Bulone's partner who encouraged me to contact her husband Vincent Bulone involving the sexual exploration of a threesome (sexual experimentation). I was given Vincent Bulone's phone number and **informed that his name was "David" ***

I contacted "David" who immediately answered and stated that he was overseas for work commitments but would be returning to Australia soon. I interacted with "David" over the course of 3 weeks who stated that he was staying in hotel accommodation overseas.

"David" encouraged a meeting with him upon his return to Australia from overseas.

"David" sent me explicit sexual photographs involving sexual acts with the woman who's photographs were on the dating site during these interactions. "David" (Vincent Bulone) informed me that his partner could not attend the meeting at the Scotty's Motel, Adelaide upon our first meeting as she had to work.

I met "David" (Vincent Bulone) on a Sunday morning at the Scotty's Motel, Adelaide upon his return. "David" (Vincent Bulone) arrived in a white Audi vehicle and met me in my room upstairs at the Scotty's Motel, Adelaide.

"David" (Vincent Bulone)

We proceeded to go for breakfast in the Adelaide CBD.

During our interactions driving to the CBD "David" (Vincent Bulone) informed me that he had lied about his name and that his actual name was Vincent Bulone - **Refer to folder 1 / text messages, "now I can use my real name Vincent instead of that other silly one" - Viber account - Deceitful Behaviour**

* Vincent Bulone then proceeded to inform me that the woman involved in the photographs on the dating site were photographs of a Prostitute named Sophia that he was involved with. Vincent Bulone informed me that he paid \$600.00 for 2 hours of her sexual services

* I felt disgusted in this behaviour of interacting with Prostitutes and felt an instant loss of respect for Vincent Bulone who had portrayed himself as dignified, respectful, honourable and a gentleman during our phone interaction before meeting.

I tried to understand his position and interaction with a prostitute for sex and continued to get to know him. We had breakfast in a café in the Adelaide CBD then proceeded to go for a drive around the Adelaide foreshores as we interacted and got to know one another more.

We returned to the Scotty's Motel, Adelaide where we drank wine together and ordered a take away meal from an Indian Restaurant.

Vincent Bulone portrayed himself as charming, well educated and seeking a relationship.

Vincent Bulone stayed with me that night at the Scotty's Motel, Adelaide and we arranged to meet the following weekend in Kadina.

We continued to interact via text messages on an everyday basis leading up to the following weekend. Vincent Bulone booked a motel room online at the Gateway Motel, Kadina for our next meeting. I met Vincent Bulone at the Gateway Motel, Kadina Saturday morning.

We proceeded to go for brunch in Moonta SA. I believed that we were starting a relationship.

Following this we continued to meet every weekend at the Gateway Motel, Kadina and then at the Wallaroo Apartments, Wallaroo SA. Vincent Bulone proceeded to tell me that he loved me and spoke to me as if we had started a relationship and led me to believe that we had.

During a interaction at the Gateway Motel, Kadina we dined at the Italian Restaurant, Bellagio, Kadina in which Vincent Bulone displayed womanising behaviour and disrespect against me by inappropriate womanising behaviour with a female staff member, waitress.

I scolded Vincent Bulone about this behaviour when we returned to the motel room, which Vincent Bulone acknowledged this behaviour was inappropriate and apologised for his behaviour. **Refer to Psychological Report - Relationship Stresses / Womanising behaviour**

I continued to date Vincent Bulone for another 3 months, interacting with him daily via text messages on a phone number that he had given me when referred to him from the dating site from the portrayed woman as his partner.

During a weekend ^{*} together after a 3 month period ^{*} at the Wallaroo Apartments Vincent Bulone ^{*} confessed that he was in a relationship with a woman in Sweden. ^{*}

I had spoken to him about moving to Adelaide to live. Vincent Bulone stated that I could stay with him at 46A Chapel Street, Norwood SA but I would have to leave when his partner flew into Australia. - **Deceitful behaviour**

He stated that the relationship was not a happy one and he didn't want to be in that relationship anymore. [↓]

* I scolded him for lying to me and leading me to believe that he was single when we met and he had confessed that the woman he was involved with was a prostitute and that he was

seeking a relationship and had been telling me that he loved me - **Refer to file 1 text messages**

* I stated that I could not be with a man that was in a relationship as this was against my morals and that he had to make a decision to leave his relationship and keep dating me or I could not see him anymore. - Refer to folder 1 text messages / "now we can go public"

* Vincent Bulone stated that he was meeting his partner in Iceland the following week when he travelled for work commitments and that he would end the relationship with her.

I received a phone call late evening from a phone number I did not recognise and missed the call. I returned the call and realised that it was Vincent Bulone's calling from his work phone. Vincent Bulone stated that he had ended the relationship with his partner Tula Terry, Sweden and that he was returning to Sweden to pack his belongings from their defacto home they shared in Sweden and that we could now be together in a relationship and

Vincent Bulone stated that he wanted to travel the world with me and arranged for me to travel to Sydney with him during a work travel commitment. Vincent Bulone paid cash for this travel arrangement. I attended this travel arrangement with him. - **Refer to Living a lavish Lifestyle / Professors income / Travel Destinations/ Cash payments**

Vincent Bulone arranged numerous lavish weekends away with him over this period, paying cash for rental houses in numerous locations. During this time I became aware of his unprofessional interactions with women work colleagues of the Adelaide University and scolded him for this behaviour of which he continued to deny and blame me for my reaction to this behaviour.

Robbie Davis, CEO of Potato Industry, who constantly rang Vincent outside of work hours and of whom Vincent had informed me that during his relationship with Tula Terry, Sweden he was sending photographs of himself to Robbie Davis and they were attending work meeting together. Vincent Bulone informed me that Robbie Davis was constantly playful with him, joking playfully with him and they often said "Goodnight " to each other at the end of a phone call. Vincent Bulone did not inform Robbie Davis that we were in a relationship or inform her that the reason he did not go to her place on the way to Robe was that we were together. He made it sound to her as if he went there alone and did not mention me at all. I was present during this phone call and questioned why he had not told her we were together and pretended he went alone. He stated that he had not told her about our relationship. He had also stated that they were good friends only. Vincent Bulone denied he conducted in unprofessional behaviour with women colleagues.

Vincent Bulone had informed Susanna, who he had never mentioned, everything about us first meeting and our relationship.

Deceitful Behaviour / hiding our relationship / Suspected personal involvement with this colleague

Michelle, Waite Campus

employee of Vincent Bulone who sought emotional support during his work travel commitments at 4am in the morning, while he was in America. Vincent stated that he emotionally supported her at 4am in the morning as she was not coping with the work related stress and complained constantly throughout our relationship of her inaccuracy and incompetence. Vincent further conducted lay offs of his staff during economic decline, lack of funding but kept Michelle in his employment.

Vincent Bulone denied his inappropriate unprofessional conduct with these 2 colleagues and stated that it was all in my mind and I was acting paranoid about their interactions.

Vincent Bulone and I continued to interact on a daily basis via text messages and continued our relationship when he returned.

I relocated into a defacto relationship with Vincent Bulone on 20th October 2018 and resided in his townhouse in [REDACTED] - **Refer to Employment**

During this defacto relationship Vincent Bulone told me to stay out of sight and quiet in the home while conducting Skype meetings with his Sweden colleagues and his parents as they did not know about me and our relationship. This occurred for close to a year before he revealed to these individuals, including his parents that we were in a relationship and that his previous relationship had ended with Tula Terry, Sweden.

Vincent Bulone and I separated 3 weeks later due to his un-supporting nature and continuous work travel commitments. I was still recovering from the incidents that had occurred while I resided in Port Pirie and required support while settling into my new environment of Adelaide of which I did not receive from Vincent Bulone.

I relocated back to Kadina - **Refer to Voting Enrolment details 9/11/2018**

Vincent Bulone and I continued the relationship. Vincent Bulone came to Kadina every weekend following the separation and I started to stay in Adelaide with him following our weekends together and returning to Kadina. During this time I quit drinking alcohol as I had discovered that I suffered from PTSD which had remained undiagnosed from the age of 19, a near death experience, held at knife point in a house by a boyfriend

Vincent Bulone portrayed himself as very loving, caring, supportive and devoted to the relationship and led me to believe that I was the love of his life and he would never betray me

Vincent Bulone took me to various locations around the world which included Bali, Europe, Norway, Sweden, France, where he introduced me to his parents in France.

I had formed a friendship with Vincent Bulone's PA, Stav, Adelaide, Waite Campus employee and had approached her while talking to Robbie Davis so that I could introduce myself to Robbie Davis as we had never met or been introduced. As I approached the position of Stav and Robbie Davis talking Robbie Davis dropped her head and ran away very quickly and without haste when she sighted me standing there. I found this behaviour to be very unusual and odd as she had not met me before or knew who I was and the procedure of Science gatherings is to met other members from industry and University's who attend these meetings. - **Unusual behaviour / suspected involvement and knowledge of targeting and in connection with David Bradley's involvement, Medical Industry/ Refer to Connections and the involvement of the Adelaide University - Refer to photograph / name badge**

I was in a relationship with Vincent Bulone between the periods of 29th July 2018 - 21st December 2019 in which time I witnessed unusual behaviour, womanising behaviour, lying behaviour, portrayed betrayal with another woman, denial of behaviour, admissions of involvement with Prostitution, encouragement to attend counselling for psychological problems concerning my mental health state.

Vincent Bulone had appeared as if he had become the target and portrayed the victim of Fraudulent Activity involving fraudulent debts created, House Cleaning service in Sweden with ex partner Tula Terry, Sweden, being threatened with Debt collectors / Newspaper subscription, Sweden, Work credit card hacking while travelling in Europe, Sexual Targeting, unknown women paying him attentive attention while in my presence dining and in various locations within Adelaide and Europe, women sending half naked photographs of themselves to his Science Twitter account, Rental car at Christmas period deposit refund, Russian couple, Queensland based Car Rental Company denying him his refund of the deposit of the rental car, 4 wheel jeep, Australian 4wd Hire / Director of liquidated company Maryna Kosukhina / husband co-director, car returned on 27th December 2019 / sub company under liquidation Smart Corporation PTY LTD, excessive rise in Taxation Department payments, quarterly payments, excessive rise in utilities, missing details on Visa which he was denied entry back to Australia, but then the issue had been fixed, while we were travelling together in Europe.

All accounts of this activity is exact replica of the illegal Activity of which I had been reporting and documenting between the years of 2014 - 2016 while residing in Port Pirie.

I told him that I thought this was unprofessional behaviour and that he is buying presents to appeal to a woman's nature not professional presents to say thank you. The presents in my opinion were of a personal nature and not professional courtesy.

Vincent Bulone denied this was unprofessional behaviour.

behind us while we were dining and continuously stared at Vincent while in my presence and was flashing her mobile phone around towards him, screen towards him with photographs on the screen. Vincent paid this unknown woman, who he claimed to not know extensive attention and kept looking at her continuously. They appeared to know one another. The woman showed me utter disrespect and our relationship and stared at me as if I was a rival.

Felicity, PHD student, KTH Sweden University, Student of Vincent Bulone

Felicity was constantly complaining of emotional issues and seeking Vincent Bulone's support of which he complied constantly. Felicity was a student of Vincent Bulone's for a 10 year period. Felicity had sent Vincent Bulone an email wanting him to attend her graduation, the email had affectionate overtones "Wish you were here" "We could have met at the hotel"

I sighted these emails on Vincent Bulone's tablet that was synchronised to his work email. 12th January 2019 I sighted numerous emails from Sweden colleagues wishing Felicity and Vincent a Merry Christmas and a Happy New Year, as if they were in a relationship and it was well known in Sweden that they were.

Suspicious of Vincent Bulone's behaviour I had stolen his tablet while he slept and took it into the Bali Villa's bathroom and sighted his emails. I questioned Vincent Bulone about who Felicity was as he had never mentioned her before, he replied "she's a PHD student in Sweden, she's hopeless though, it's taken her 10 years to graduate, she keeps getting pregnant."

Vincent Bulone stated that he was being questioned and reprimanded in Sweden, KTH University for his students being in his tuition for long periods of time and that he was being questioned about his personal involvement with them.

Vincent Bulone informed me that he had been reduced back down to Professor from Director of Research in Sweden following this statement.

Vincent Bulone researched grants of which I could apply for in order to develop the projects. Vincent Bulone provided information involving Bill Gates Foundation and Nicole Ross Foundation. I applied for a grant with Nicole Ross while travelling in Sweden 2019, email contact. I was denied the funding by Nicole Ross.

I then realised that this is how the individuals who had been targeting me had been altering messages and breaking my contact with friends by sending nasty messages claiming to be from my phone, which had also included to my children, altering our relationships. I also realised that this was how my profile was being distributed as for the Sexual Targeting, Black Market Sex Site, without my knowledge or consent.

My eldest son had received a text message claiming to be from my phone while I travelled in Europe which was nasty and he had replied "I don't think that message was meant for me" I replied the last message that I had sent to him was to wish him "Happy Birthday" before I left for Europe.

My daughter who I have never had issues with or there has never been issues between us suddenly without explanation stopped talking to me while I was travelling in Europe and our relationship is now strained. My daughter claimed that during the break down of her relationship she was not in a good place in her head and was very emotionally troubled and she was dealing with issues between us from our past. There has not ever been issues in our past and we had stayed in constant contact since she was 12 years old and moved to Melbourne to reside with her father. My daughter is now in another relationship with a young man named "Chris", who she sent me a photograph of this young man. Our relationship remains strained - Suspected targeting of my children with altered text messages segregation of the family / mother from children

Vincent Bulone is of Italian decent / origin / Sicily

***I ceased all contact and conduct of seeking relationships or friendships to protect myself against the targeting, which has continued in 2020. I have remained in isolation as a measure of caution until this is resolved - Legal Prosecution based on the evidence**

- * After showing Vincent the evidence of the Intellectual Property Theft and targeting at my parents home he said that it was viable and real but insisted that I remove the section of his suspected targeting of the ARC committee and then started to contradict his information about his phone being hacked and certain other areas of the information.
 Vincent continuously denied his behaviour with other women and said that I was delusional and making up stories about his unusual behaviour, which had been identical behaviour of the other men who had targeted me, Shaun Steele, Paul Gardner, George Gorgio and David Johnson. Vincent insisted that I get therapy for confronting him but insisted that he did not want to talk to the therapist about his behaviour. I pray for all of you as I will also always love you, especially you [REDACTED]. Until I die. You too take care my love. Xxx love you.
 Try to sleep now [REDACTED], it's the middle of the night. I truly love you too believe me and I will never be with anyone else. I am also looking into where and what to do with my life. I am so sorry to hear your mum got this health problem and I pray she will recover well. In a way it is best that they operated her otherwise it could have been fatal at a later stage. If she rests well she will actually feel better than ever. one of my friends had the same and he said he is now like a 20 year old man! Rest now [REDACTED]. You have been and will always be in my mind every minute since we stopped communicating through Viber. It's been a very hard time for me too. Rest and sleep. There is always tomorrow to look forward for a better life. Thank you and I love you too forever. Deep in my heart. Xxx
- * After this message the phone suddenly cut off and I could no longer send or receive messages. I reported this to the Telstra shop in Kadina, it was an escalated incident and I was informed that it was like the server on the other end was switched off but they had fixed the problem. Vincent had said in another message before this time that we would always stay in contact as friends and catch up occasionally. He said I hope you meet a business man who makes all your dreams come true - conflicts with Vincent's jealousy written in the psychological report given to Dr Nicole Manslow, Adelaide Psychologist, who was also given a copy of the evidence of targeting and Intellectual Property Theft.
 Vincent stopped answering all of my messages sent to his Swedish phone and his Adelaide phone. Conflicting with his messages of love and staying in contact.

* I recently went to Adelaide and went to his university when he got back from Sweden on the 20th of February - his PA, my friend had informed me that he was leaving Sweden on the 9pm flight. Vincent denied this and said I must have got it wrong when I contacted him on his Adelaide work phone on the Saturday and did not want to see me on the Sunday. When I went to his university recently, Tuesday 3rd March 2020 he was not in his office upon my arrival so I left a letter for him with his PA, Stav and told Vincent that I was staying at the Scotty's Motel and to come have dinner with me. Vincent would not answer my text messages sent to his Adelaide work phone and did not meet with me at the hotel. I went to his home at around 7pm, he was not there so I went to his university and he was not there either and seemed to be avoiding me which conflicted with his valentines messages and message that we would always stay in touch. I left packages of this information with Stav to give to Natalie Betts and Julian, employees of Professor Vincent Bulone and personally gave this information to dave, Vincent's financial advisor.

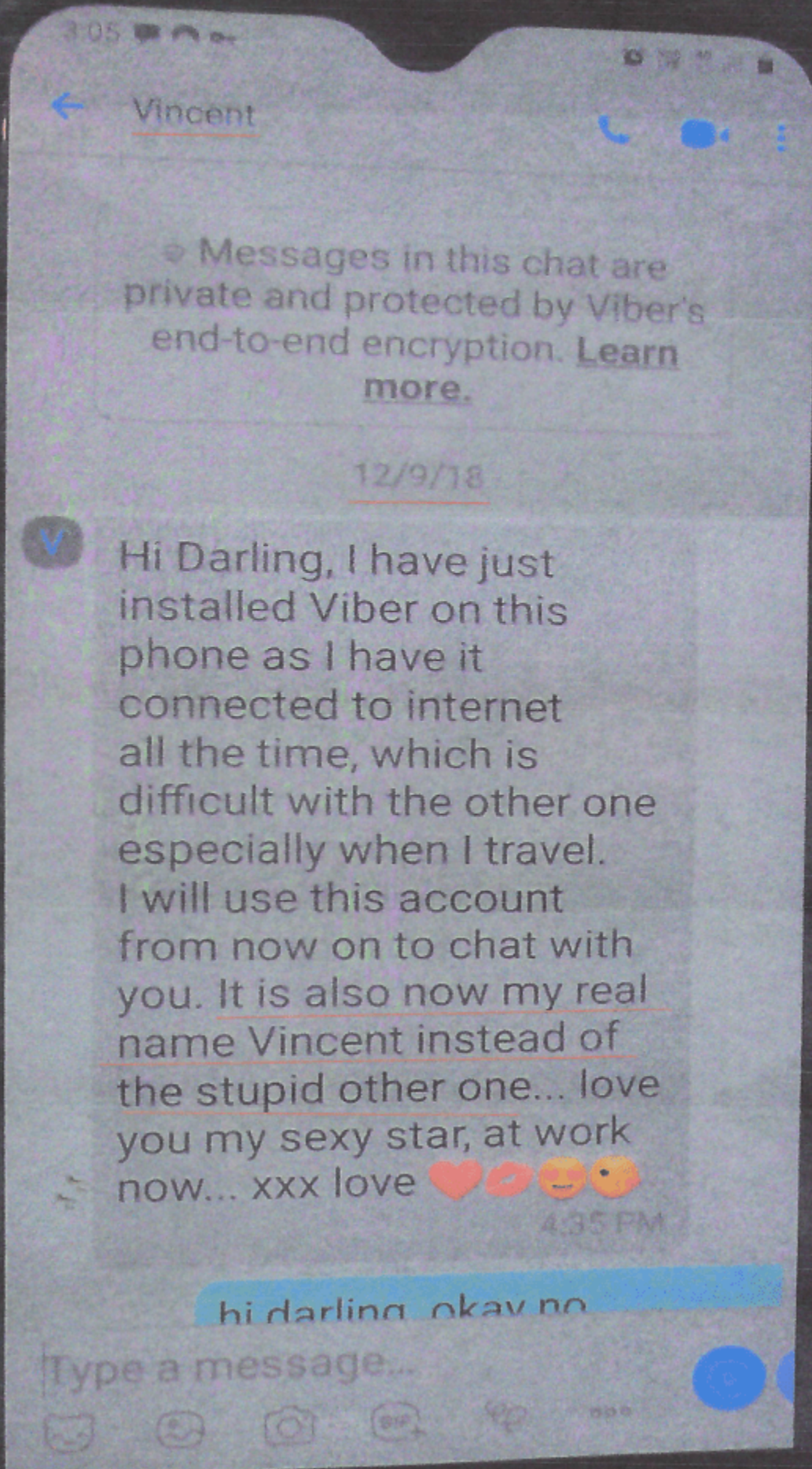

INTELL PROP THEFT IN VINCENT BULONE POSSESSION DECONTAMINATION PROJECT

Vincent Bulone informed me that he was in interactions with his previous partner about selling his half of the defacto home he shared with her in Sweden. His interaction with Tula Terry, Sweden had continued throughout our relationship in secret. I had witnessed there interaction on his personal tablet that was synched with his work phone.

Vincent Bulone had treated Tula Terry, Sweden leading up to when we started our relationship as if she was still the love of his life and their relationship was not unhappy. The couple were still holidaying together and he sent her love notes, called her darling, princess and acted as if he still loved her. Vincent Bulone during their interactions in this relationship had been sleeping with a prostitute over a 2 year period, before we had met and was on a dating site AMM Dating site (Adult Match Maker) displaying photographs of the prostitute Sophia on his profile.

Vincent Bulone was sending explicit photographs to phone numbers of his genitals on his work phone while in this relationship before we had met.

1. I am a Senior Constable of Police, ID [REDACTED] currently stationed at CRYSTAL BROOK Police Station.
2. I commenced this statement at about 6.15pm on Sunday the 22nd of May 2016.
3. At about 10.10pm on Thursday the 4th of February 2016, I was in company with Brevet Sergeant Daniel NICHOLSON, obtaining a meal at the drive through at MCDONALDS, located on Main Road PORT PIRIE.
4. It was at this time I heard a female yelling and screaming, I couldn't make out what she was saying.
5. As I drove from the drive through I could hear and now see a female walking in a northerly direction along Main Road, she was yelling out 'you fucking dogs'. It was at this time that I observed and Senior Constable Farried MUHSIN following the female on foot.
6. A short time later I observed Constable Gary BROCKHOUSE drive his police fleet into the carpark of MCDONALDS. I parked my police fleet near BROCKHOUSE'S as I observed MUHSIN and BROCKHOUSE struggling with the female. I assisted in controlling the female while she was handcuffed:

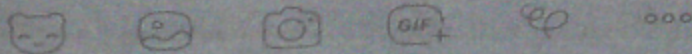

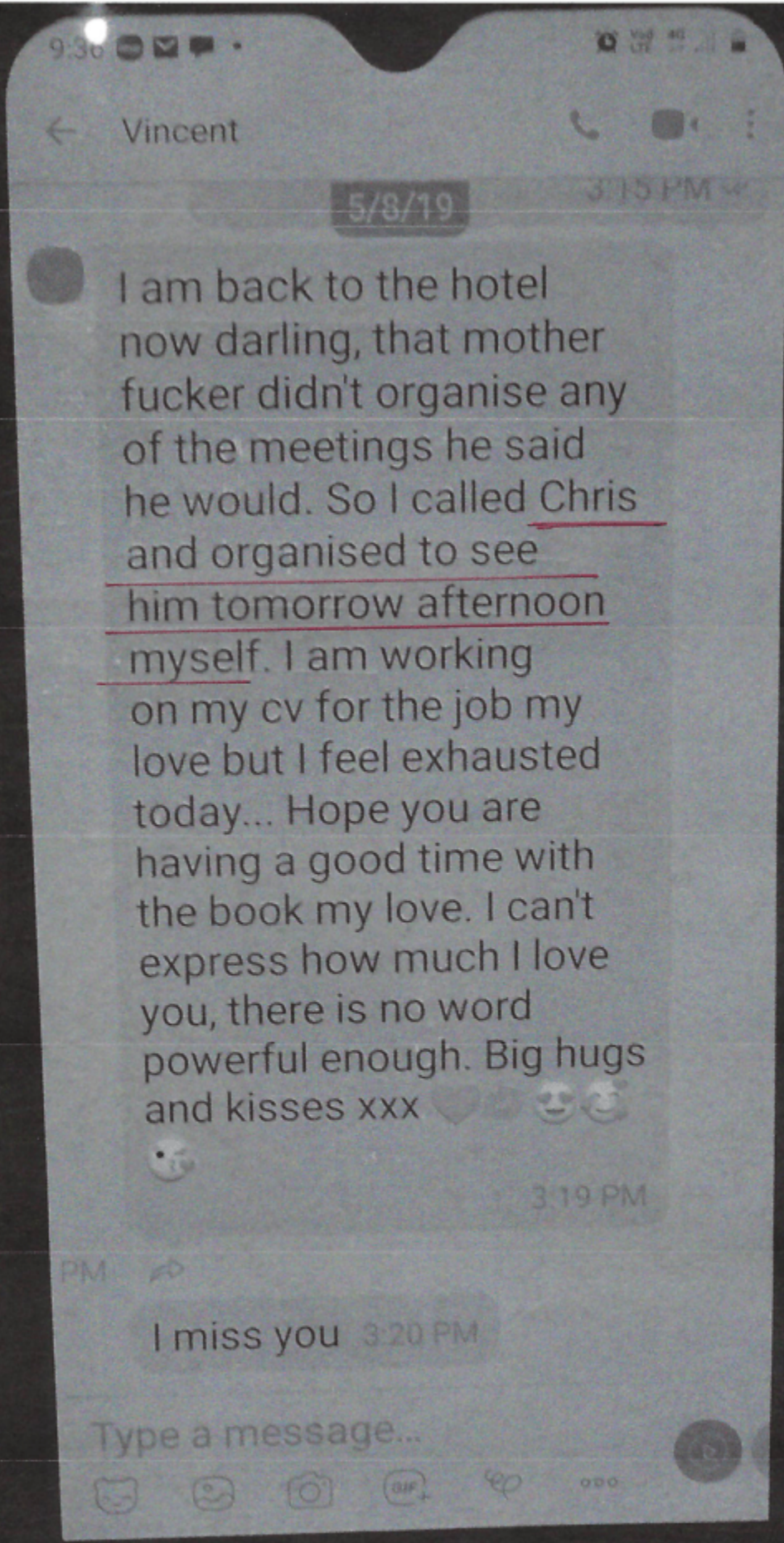

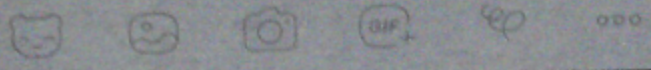

residence as Saudi Arabia.^{[50][51][191][192][193]} According to his attorneys, Epstein had been advised to acquire the passport because "as an affluent member of the Jewish faith", he was in danger of being kidnapped while traveling abroad.^[194]

On July 8, prosecutors with the Public Corruption Unit of the Southern District of New York charged him with sex trafficking and conspiracy to traffic minors for sex. The grand jury indictment alleges that "dozens" of underage girls were brought into Epstein's mansions for sexual encounters.^{[11][12][195]} Judge Kenneth Marra was to decide whether the non-prosecution agreement that protected Epstein from the more serious charges should still stand.^[196]

Epstein requested to be released on bond, offering to post \$100 million with the condition that he would also submit to house arrest in his New York City mansion.^[197] U.S. District Judge Richard M. Berman denied the request on July 18, saying that Epstein posed a danger to the public and a serious flight risk to avoid prosecution.^[197]

On July 23, Epstein was found injured and semiconscious at 1:30 a.m. on the floor of his cell, with marks around his neck that were suspected to be the result of either a suicide attempt or an assault.^[198] His cellmate, former New York City police officer Nicholas Tartaglione, who was charged with four counts of murder, was questioned about Epstein's condition. He denied having any knowledge of what happened. Epstein himself said he recollected nothing.^{[190][199][200][201]} According to NBC News, two sources said that Epstein might have tried to hang himself, a third said the injuries were not serious and could have been staged, and a fourth source said that an assault by his cellmate had not been ruled out.^[202]

On August 29, 2019, following Epstein's death 10 days prior, the case against Epstein was closed after Judge Berman dismissed all sex trafficking charges.^{[17][18]} However, he also expressed support for Epstein's accusers.^[17] Prosecutors objected to the ruling and stated they would continue an investigation for potential co-conspirators.^[18]

Investigation in France - VINCENT BULONE - SEXUAL TARGETING 2018 - 2019

On August 23, 2019, the prosecutor's office in Paris, France, opened a preliminary investigation into Epstein. He is being investigated for rape and sexual assault of minors under and over the age of 15, criminal association with a view to committing crimes, and association with criminals with a view to committing offenses. The prosecutors said that the goal of the investigation is to find possible crimes committed in France and elsewhere against French citizens.^[203]

Personal life

Previous long-term girlfriends associated with Epstein include Eva Andersson-Dubin^{[204][205]} and publishing heiress Ghislaine Maxwell.^[30] Epstein was romantically linked to Andersson-Dubin for an 11-year period^[206] mostly in the 1980s and the two later remained friendly well after her marriage to Glenn Dubin.^{[204][205]} Epstein met Maxwell, daughter of disgraced media baron Robert Maxwell, by 1991.^{[162][207][208]} Epstein had Maxwell come to the United States in 1991 to recover from her grief following the death of her father.^[209] Maxwell was implicated by several of Epstein's accusers as procuring or recruiting underage girls in addition to once being Epstein's girlfriend.^{[161][162][208]} In a 2009 deposition, several of Epstein's household employees testified that Maxwell had a central role in both his public and private life, referring to her as his "main
