ICAC / OPI reply letter states :

ICAC - OPI - Deny any form of illegal targeted activity of the reports and submitted extensive and multiple documented evidence to support the report made by the targeted victim and states:

" The further information you have provided does not cause me to reconsider my earlier determination"

"The gravamen of your complaint has been considered and assessed as requiring no further action"

"Accordingly, your file will remain closed"

"I do not intend to correspond with you further in relation to the issues you have raised and have instructed the OPI to file future correspondence from you relating to these issues without response."

Hon Bruce Lander Involvement in :

Denial of ICAC / OPI denying the reported illegal targeted activity by the targeted victim resulted in the continual Entrapment of the targeted victim in the Criminal Network targeting of an individual, that commenced when the targeted victim was 14 years of age, while residing as a minor in Kadina SA - [John Olsen, MP - Liberal Government - Source of Commencement and connected to new York, America - Epstein and Maxwell - Sexual Abuse Ring involving powerful prominent people](#)

#### 2017-2019 : targeted victim

Targeted victim relocated from Port Pirie to Kadina in 2017 following release from illegal detainment in Glenside Mental Health Institution under the assumption the targeted activity was contained to the Port Pirie region only and involved the individuals involved in the Intellectual Property Theft of the Specialist Medical Centre and M.S.I.C and the targeting had ceased, and following the denied illegal activity of 2017 ICAC/OPI under the assumption it was the last resort of which she could report to and resolve the issue the targeted victim ceased all reports concerning the illegal targeted activity and commenced rebuilding her life in Kadina while residing in her parents home, Cynthia and David Pearce until 2018 - 2019

2018-2019 - Continual Criminal Network targeting of an individual involving Destruction of Career for sexual demand of a Sexual Abuse ring connected to Epstein and Maxwell and Government and Police sources, and including individuals involved and connected commenced and continued in 2018 - Conspired Sexual targeting and continual Multiple Intellectual Property Theft 2017-2021, and including Sabotage of a Publishing career / Author

2018 - 2019 Conspired Sexual Targeting of an individual involving Vincent Bulone - France connections - Sweden Connections / Foreign - Australia Connections - Government connections - Connections to individuals previously involved in targeting of the targeted victim 2007—2015 / Motorcycle gang members

Targeted victim targeted by Vincent Bulone in July 2018 during the period of her business development first manuscript "Reality" and had obtained a publishing contract in July 2018 Conspired sexual targeting of Vincent Bulone, an individual involved and connected to motorcycle gang members confirmed as involved and connected, and also connected to Government sources and criminality in France involving Epstein and Maxwell displayed the exact Pattern of Behaviour as previous individuals involved in Conspired Sexual targeting occurring at the exact time of each business development that resulted in either Intellectual Property Theft or Sabotage of Career - Conspired Grooming of the targeted victim for sexual purposes of a Criminal Network targeting an individual involving Sexual Abuse Rings and connected to Epstein and Maxwell

Targeted victim recognised the Exact Pattern of behaviour and ceased all contact of the portrayed Conspired relationship of Conspired sexual targeting with Vincent Buolne in 2019 and commenced reporting the illegal targeted activity, seeking assistance and constructing the Constructed legal Case Files, Character reference, Stage 1, 2, 3, 4 and continual construction and reporting until 2022.

Reply letter received following targeted victim submitting extensive constructed documented Legal case files containing Character reference, Stage 1, 2,3,4 and containing documented evidence of Police and Government sources of a criminal Network confirmed as targeting of an individual, and involving the corporation TELCO involved in identity Theft of the targeted victim and multiple counts of Criminal activity, and including official letters of the Government sources conspiring against the targeted victim in 2020 involving a third attempt of Conspired Assassination under the exact same order of 2017, and all individuals involved and connected to one another in conspired attacks during the periods of 2007-2019, and the continual Intellectual property theft / Destruction of career for sexual demand of a Sexual abuse ring connected to Epstein and Maxwell, and including Stage 4 Intellectual Property theft of the Intellectual property of the targeted victim involving hand written business concept of a Corruption department commencement of business development 2013-2016, while residing in Port Pirie, submitted personally delivered by targeted victim to ICAC/OPI in May 2021-December 2021.

Your complaint has been registered and referred for assessment to the Internal Investigation Section (IIS) of South Australia Police / SAPOL - In reference to reported and submitted constructed legal case files pertaining to the Conspired Police targeting 2014-2016 resulting in 2017 illegal detainment and intention of Conspired Attempted Assassination of the targeted victim by Lethal injection to appear as suicide under a Falsified mental Health order involving Forensic Mental Health services, and the submitted confirmed evidence of Police sources involved in targeting of an individual, including Origin account encountering Queensland Police sources money laundering from the targeted victim through Fraudulent utility accounts / Excessive rise in billing / barcode scanned as "Townsville CC Parking Fines, Queensland"

Reply letter received by the targeted victim from SAPOL Internal Investigations - Joanna Sharman APM states :

Complaint has been entered into the complaints management system and assigned registration # C2022-1025

I have reviewed your complaint and carried out an assessment - Police complaints and Discipline act

I have noted these matters have previously assessed in another complaint that you made # C2016-0877 - Reports made by the targeted victim to Grant Stevens, Police Commissioner and Police Ombudsman in 2016 prior to 2017 illegal detainment and denied any form of illegal conduct by police officers involved in Conspired Police targeting 2014-2016 resulting in Conspired Illegal detainment in 2017 to result in Conspired Attempted assassination of the targeted victim by lethal injection under a falsified Mental Health order - Forensic mental Health Services - Vickie Chapman, Attorney General of SA connected to Steven Marshall, Premier of SA

I am now closing your new complaint as, vide section 15(a) of the act. I consider it has already been dealt with by my section.

- ICAC / OPI involvement in Conspiring with Joanne Sharman APM of SAPOL Internal Investigation and Government and Police sources involved and connected in a Criminal Network targeting of an individual to Cover up Police targeting that resulted in 2017 Illegal detainment of the targeted victim with the intention of Conspired Assassination of the targeted victim by lethal injection to appear as suicide under the act of a Falsified Mental Health order connected to Government sources involved in Criminal Network targeting of an individual over a 30 year period and her awareness of the Intellectual Property theft of her Intellectual Property The Specialist Medical Centre and M.S.I.C connected to Epstein and Maxwell and contested in 2013 with an Intellectual Property lawyer and reporting recognised illegal targeted activity involving Fraudulent activity 2015-2016
- SAPOL Internal Investigations Joanne Sharman AMP involvement in Conspired Cover up of involved SAPOL officers involved and connected in Criminal network targeting of an individual with the intent to cause grievous bodily harm and death of the targeted victim to appear as suicide and conspiring with Government sources involved in a Criminal network of targeting of an individual and connected to Epstein and Maxwell involving Destruction of the targeted victims career for sexual demand of a Sexual abuse ring involving Criminal Network individuals and powerful prominent people

Reply letter received by the targeted victim from ICAC/OPI following the submitted constructed legal case files Character Reference, Stage 1,2,3,4, and including file Stage 1B Pattern of targeting - Chentelle Defoe and JC Designs

ICAC/OPI Reply states :

"While I acknowledge that the experiences you describe have been distressing for you, I do not think that there is sufficient information available to support the allegations to justify a referral to another agency for further assessment"

"In light of the above I have determined to take no further action in respect of your complaint pursuant to section 18E(1)© of the ICAC act

"As no further action will be taken, I will now close the file"
